In the meeting following decisions and recommendations were made:

Keeping in view the interests of the students, various institutions affiliated to IKGPTU, offering different courses in Journalism and Mass Communication, it was decided to endorse the decisions taken in the BoS meeting held on 7.12.2015.

In that meeting, the Board had strictly decided to follow the UGC guidelines regarding the nomenclature of various courses. It was recommended that the Masters in Mass Communication and Media Management and M.Sc. (Journalism, Advertising and Mass Communication) and B.A. (Mass Communication) courses should be considered as M.A. (Journalism and Mass Communication) from the new academic session -2016-17 as per UGC guidelines

The B.Sc. (Media, Entertainment and Film Technology) and B.Sc. (Journalism and Mass Communication) courses be closed and B.A.(Journalism and Mass Communication) should be started from the new academic session -2016-17 as per UGC guidelines. The curriculum followed in these courses may remain unchanged for the current academic session.

Due to the sentence formation of earlier drafted & signed minutes of meeting dated Jan.25, 2016, BoS is signing on revised minutes of meeting.

As per the UGC Gazette dated July 5, 2014, Part III- Section 4, page number 2987:

Page number 2993 of the Gazette specifies at number 7 reproduced as mentioned:

"Henceforth, Universities shall not introduce any new nomenclature of degree unless there is a very strong and genuine reason. Should a University intend to introduce a new nomenclature, it shall approach the UGC for its specification at least 6 months prior to starting the degree programme along with details of the courses of the study prescribed for the degree as approved by the respective academic bodies of the University/institution, such as BoS, Academic Council and Governing Council".

Members of BOS also considered the final letter regarding distance education to IKG PTU ref no. UGC/DEB/13/2/PTU/2015 dated 05.08.2015, where UGC approved course as BA (Journalism & Mass Communication), MA (Journalism and Mass Communication) (Copy attached)

Finally BOS decided to go with UGC guidelines only.


In the meeting, following unanimous decisions and recommendations were made:



5. The list of question paper setters was also recommended for Master of Arts (MA) II & IV semester of Journalism & Mass Communication. (Annexure-IV)


