

**ADMISSION CRITERIA AND PROCEDURE FOR ACADEMIC SESSION 2017-18 :**

Admissions to all the AICTE & Non-AICTE courses shall be made through Centralized counseling to be conducted by the University.

1. **Eligibility Criteria :** The eligibility criteria for admission to B.Tech., B.Tech. (LEET), B.Arch., M.Tech., M.Arch. and MBA courses shall be same as notified by Punjab Government.

2. The eligibility criteria for M.Tech-Food Technology is as below:

Sr.No.	Course	Eligibility
1.	M.Tech-Food Technology (Nutrigenomics)	Graduation(4 years course) in Food Technology/Food Engg./Food Science & Technology/Agricultural Engg./Food Processing/Nutrition/Biotechnology/Fermentation Technology/DairyTechnology OR M.Sc(2 years course) in Food Technology/Biotechnology/Food Science & Technology

3. The eligibility criteria for Non-AICTE courses is prescribed as given below:

S.No.	Course	Eligibility
1.	M.Sc. – Physics	Passed B. Sc. with 50% marks having Physics as one of the subject in B.Sc. (45% in case of Candidates belonging to SC/ST category).
2.	M.Sc. – Chemistry	Passed B. Sc. with 50% marks having Chemistry as one of the subject in B. Sc. (45% in case of Candidates belonging to SC/ST category).
3.	M.Sc. – Mathematics	Passed B. Sc. with 50% marks having Mathematics as one of the subject in B.Sc. (45% in case of Candidates belonging to SC/ST category).
4.	M.A. – Journalism & Mass Communication	All those candidates who have passed Graduation with 50% marks in any discipline (45% in case of Candidates belonging to SC/ST category).
5.	PG Diploma – Universal Human Values & Ethics*	Graduation with 40% marks in any discipline
6.	M. Tech. – Holistic Development-Systems & Technologies*	Graduation with 55% in any technical stream B.E./B.Tech or equivalent.
7.	BCA	All those candidates who have passed the 10+2 or its equivalent examination in any stream conducted by a recognized Board/University/Council. <b>OR</b> Those candidates who have passed their Matriculation examination and have also passed three year Diploma in any Trade from Punjab State Board of Technical Education & Industrial Training, Chandigarh or such Examination from any other recognized State Board of Technical Education, or Sant Longowal Institute of Engineering & Technology, Longowal.

\*The final selection in PG Diploma in Universal Human Values & Ethics and M.Tech – Holistic Development – Systems and Technologies will be made through interview process.



2. **Reservation:** The reservation of seats shall be as per Punjab Government, Department of Technical Education and Industrial Training.
3. **Procedure for admission to AICTE & UGC courses:**
- Admissions to all the courses shall be made through Central Counseling being conducted by IKGPTU on behalf of Government of Punjab.
  - For AICTE courses the eligibility, procedure, reservations, fee to be charged and all other conditions notified by Government of Punjab for the session 2017-18 shall be applicable for admission to the courses at IKGPTU Main Campus and Constituent Campuses.
  - The information about the eligibility for admission to different courses and reservation of seats for various categories shall be made available by I. K. Gujral Punjab Technical University, Jalandhar on website [www.ptuadmissions.nic.in](http://www.ptuadmissions.nic.in), [www.ptu.ac.in](http://www.ptu.ac.in) & [www.maincampus.ptu.ac.in](http://www.maincampus.ptu.ac.in)
  - There shall be two rounds of centralized counseling by I.K. Gujral Punjab Technical University, Jalandhar. The counseling schedule shall be as notified by IKGPTU & shall be available on its website. Thereafter the direct admissions at the level of University & Constituent campuses shall be made for vacant seats.
  - To fill the vacant seats in University main campus & Constituent campuses expeditiously after 1<sup>st</sup> round of counseling, parallel registration of eligible candidates for admission shall be done. All such candidates registered directly through online portal for admission to IKGPTU shall be entitled for admission only if seats remain vacant after 2<sup>nd</sup> round of centralized counseling.
  - For MBA course, non-CMAT candidates are also eligible to apply and will be allowed to register for admission.
  - After following above said procedure, if still the seats remains vacant in reserve category, the University will fill these from candidates belonging to general category in subsequent step at the end of counseling.

**Scholarship to meritorious students:**

- 100% tuition fee waiver for students with Gold Medal in the qualifying examination at Institution Level.
- 50% tuition fee waiver for students with more than 70% marks in the qualifying examination.

The scholarship shall be offered to the students till the completion of their course.
