In morning of 13th October 2019, I was alone in the room, when around 15-16 4th year students barged into my room and started arguing with me about last night and suddenly one of them named Akhilesh Chauhan punched me vigorously. I then got frightened and tried to defend myself. Some of them caught me and started punching me in face because of which my nose started bleeding me. Then they threatened me and left. In the evening one of them threatened me not to disclose this matter to anyone or they would do the same again. Now I am saddened and depressed due to this incident and in fear to stay in the hostel and not able to concentrate on studies. I've lost my self-esteem and I fear to face anyone in the hostel. In the past also they've tried to target me and show off their superiority. I request you to take an appropriate action against their misbehavior. 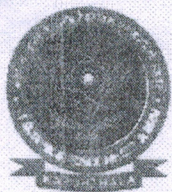

4. He lodged Anti-Ragging complaint on UGC portal to get support for himself.














Concluding Remarks

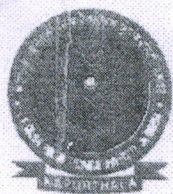


After Investigation, a meeting was held between the committee members on 15th November 2019 at 6:00 PM and it was concluded that the all following four students.

- Raghav Sethi, B.Tech (CSE) 3rd year


are equally found guilty in the said quarrel held on 13th October 2019. In this meeting the committee recommends the following points -

3. These students should also be ward to enter in the premises of hostels.




