Item, No. 1 To apprise LLC about RFID Implementation.

The Deputy Librarian apprised all the committee members about the implementation of RFID system. The Knowledge Resource Centre has enhanced the security features and is using the Radio Frequency identification system LSMART. RFID system was inaugurated by Hon'ble Vice Chancellor, on dated 16th January, 2019. This RFID Technology has improved circulation and inventory control for best tracking, misplaced books and security/ issues.

Item No. 2 To apprise LLC about completion of Library Automation.

The Deputy Librarian apprised all the committee members about the completion of Library Automation. The Knowledge Resource Centre's all Operation are fully automated. The Latest version of the most advanced software (Web Centric Software LSEase EJB Version) is being used which has the facilities of fully automated Library. Library Automation was inaugurated by Hon'ble Vice Chancellor, on dated 16th January 2019.

Item No. 3 To apprise LLC about Mobile Applications.

The Deputy Librarian apprised all the committee members about the implementation of Knimbus Mobile Application. The Knowledge Resource Centre has developed its own Mobile applications. The Mobile Application was inaugrated by Hon'ble Vice Chancellor, on dated 30th August, 2018. All the e- Resources and e-books available in Knowledge Resources Centre are accessible through this mobile application.

Item No. 4 To apprise LLC about Stock Verification done in 2017 and 2019.

The KRC has automated its operations using Libsys Software and RFID Technology. Accordingly all the books present in the KRC were physically verified, tagged and entered in the Libsys software. During all this process the physical stock verification of KRC books was also done.

Firstly in 2017 the Internal stock verification was done and accordingly 70 books were found missing. This list of 70 books was re-checked in August 2017 during shifting & shelving of books in new KRC building. 15 books out of this 70 books were found in the KRC, so the total books missing till 2017 were (70-15=55). Then in 2019 during the RFID tagging work, individual book the staff on duty again checked all the stock and found the same 55 books were missing in the KRC.

It is hereby cleared that from 2001 to 2019 (in 18 years) only 55 books were found lost from the KRC. The list of 55 books found missing in KRC is attached with. The information about the same was put up to the Hon'ble Vice Chancellor for their kind approval. Further, It is being brought to the kind information of LLC that for automated Stock Verification, the requirement for Wi-FI Handheld Reader Device was moved in 03.06.2019 the same has been approved by Hon'ble Vice Chancellor.

So, it is expected that before next LLC meeting the device will be purchased and a new committee will be formed by LLC to carry out the Stock Verification using these devices.

Item No. 5 To apprise LLC about Implementaion of CCTV cameras in KRC.

The Deputy Librarian apprised all the committee members about the implementation of CCTV cameras in KRC. To enhance security and surveillance process of CCTV cameras has been installed in Knowledge Resource Center.

Item No. 6 To apprise LLC about complementary access of e-journals.

The Knowledge Resource Centre has provided the complementary access of below mentioned e-journals to its Research scholars/ Officer/ Faculty of IKGPTU. The detail is as below.

The Knowledge Resource Centre had organized a National Workshop on "Academic Writing and Research Productivity" for two days from 4th and 5th February, 2019.

Item No. 10 To apprise LLC about Launch of EBSCO Discovery Service (EDS) and Orientation Program.

The Deputy Librarian apprised all the committee members that Launch of EBSCO Discovery Service (EDS) and Orientation Program was conducted on dated 18th March 2019 which was inaugurated by Ho'ble Vice Chancellor. Benefits of this EBSCO Discovery Services and Training to the users were also provided.

The Orientation to Library Resources and services was also provided by Deputy Librarian.

Item No. 11 To apprise LLC about Scopus Training Program :-

A Scopus training was also arranged for faculty and students on dated 26 Sepetember, 2019.

Ms. Tahseen Khanday from Elseivier provided the training on Scopus Database. This database is highly useful for various Bibliometric analysis related to NIRF, NAAC, NBA etc.

Item No. 12 Rules for Purchase of e-books.

The rules for e-books purchase are not mentioned in notified SOP. So the same was discussed for formulation of rules for e-books purchase. After discussion, the Committee recommends that if there is requirement of one single e-book then that may be purchased online from Amazon, Flipkart or from concerned publisher etc. The Deputy Librarian is authorized to purchase such books from imprest amount.

If their is any bulk or package requiments of e-books then the rules as defined in SOP 4.4 for subscription of e-journals etc. may be followed.

Item No. 13 Formulation of Kindle Issue/ Return policy.

To encourage the reading habits of Library users, the KRC has purchased 5 kindles for faculty/ officers of IKGPTU and this kindle sevice was inaugurated by Ho'ble Vice Chancellor, on dated 19th October, 2019.

The draft of Kindle Issue/Return policy is mentioned below:-

- 1. This service is only for faculty/ officers of IKGPTU.
- 2. Kindle will be issued for 15 days only.
- 3 The borrower should check the condition of Kindle before getting it issued. The borrower will be held responsible for any defect/ damage found at the time of return of the Kindle, if not recorded on it earlier, and will be liable to pay the penalty as decided by the Registrar/ Deputy Librarian.
- 4. A borrower is responsible for the safe custody and return of the kindle borrowed from the Knowledge Resource Centre, IKGPTU.
- Every user in whose name a Kindle account is issued will be responsible at all times for its proper and ethical use.
- 6. Users should not let other persons use their name, login, password, or files for any reason.
- 7. Users should not use others, system accounts or try to discover other user's passwords.
- 8. Users should not erase, rename or make unusable anyone else' Kindle files, programs etc.
- 9. Users should adhere to the copyright policy.

This draft policy is submitted for kind approval of competent authority.

Item No. 14 Purchase of Books in library.

It is briefed that during 2014 the empanelment of vendors was finalized after the tender advertisement, the emapanelment of vendors has expired on dated in 31th decmeber, 2019.

Now, from 2016 the SOP of libray is notified. The committee discussed that as there is already a well drafted and notified SOP of KRC is available. The rules for purchase of books are clearly defined in this SOP. So in future all the purchases of books will be done as per notified SOP of KRC. So the committee recommends that from 2021, all the books purchase etc. will be done as per rules defined in notified SOP.

With reference to the approval of the Worthy Vice Chancellor a committee had been constituted for evaluation of available software and installation of RFID solutions for IKGPTU Knowledge Resource Center. The meeting of the said committee was held in the O/o Incharge Secretariat. 1st Floor, IKGPTU on August 1, 2018 at 02:00 PM.

The following points were discussed:-

- It was briefed that presently. Library (KRC) is using LSEase software. Keeping in view the latest library practices M/S LibSys has upgraded this software to "Web Centric LSEase" which has many advanced sophisticated features. The committee members were unanimous regarding upgradation of the present software to "Web Centric LSEase". Further, it was strongly felt that bodies like NAAC and AICTE always lay emphasis for latest sophisticated library management software. The committee strongly recommended the upgradation of present software to "Web Centric LSEase". The approx. expenditure involved for the purpose is Rs. 2,70,000/-.
- LIBSYS LSEase software. So, it will be in the fitness of things if hardware component of the RFID technology to be purchased is compatible with this software. If any other RFID hardware is purchased that won't be compatible with the presently used software. It's not advisable to do away with the present library management software. The committee members strongly recommend that IKGPTU should go for LIBSYS RFID technology. Members appreciated that M/s LIBSYS Ltd, Gurgaon has already successfully installed this technology in 91 premiere institutions of India. (list enclosed at 'A'). The purchase orders and project costs submitted to other institutions by the same vendor was also gone through and committee found that the project cost submitted to IKGPTU is at par with other institutions. The supply orders of other institutions for the comparison of project cost are attached at 'B' to 'H'. The approx. project cost for IKGPTU is 14,00,000+ GST Extra. The proposal submitted by the Libsys is attached at 'I'. Since it is a Proprietary item, so, the committee

, recommends that procurement be made on proprietary item basis from M/s Libsys Ltd. A certificate of proprietary article and a certificate of least prices be obtained from the supplier.

- The committee members strongly felt that this library should adopt dual security system. For this it 3. was proposed that along with RFID tags electromagnetic tapes (EM tape)should also be used as security measures, because the RFID tags can be easily tampered by students.
- The committee deliberated that Mobile Application is a latest technology and provides library 4. resources to faculty/ students on their mobile sets. Many librarians, experts etc were consulted and a good response was received for Knimbus Mobile Application. It is supported in IOS/ Windows version. The positive feedback has been received from the institutions; where this application is working (feedback is attached at 'J'), therefore the committee recommends that the Knimbus Mobile Application may be procured. The proposal submitted by the Knimbus is attached at 'K'. The purchase orders and project costs submitted to other institutions by the same vendor was also gone through and committee found that the project cost submitted to IKGPTU is at par with other institutions. The supply order of other institutions for the comparison of project cost are attached at 'L' to 'O'. The approximate project cost for IKGPTU is 1,85,000 + GST extra. Since it is a Proprietary item, so, the committee recommends that purchase of mobile application may be made from Knimbus Mobile Application on proprietary article basis. A certificate of proprietary article and a certificate of least prices be obtained from the supplier.
