Celebration of Commemorative days, events and festivals

1. WORLD WETLANDS DAY 2019

2nd February, is observed as World Wetlands Day all over the world and the theme for this year's 2019 WWD was "Wetlands & Global Climate Change". Wetlands play a key role in mitigating global climate change but are fragile and most threatened aquatic ecosystems. Wetlands act as great carbon sinks thus reducing the impact of global greenhouse gases. Covering about 6% area of the Earth's surface, they store 35% of global terrestrial carbon, which if released in gaseous form can cause disasters.

Acknowledging above facts, the Department of Chemical Sciences, I K Gujral Punjab Technical University, Kapurthala observed World Wetlands Day on 7th February, 2019 at its main campus where more than 120 students across various disciplines participated in the event. Two lectures were organized, where Dr. Chander Parkash of Chemical Sciences made students aware about the importance of wetlands, their functions & values whereas in second lecture Dr. Onkar Singh Barraich from Department of Zoology, Punjabi University, Patiala gave information on importance of Wetlands in Global Climate Change. He expressed that how the global climate change can bring biological changes among different species which will alter species composition of many areas around the world. An on the spot poster making competition was organized in which Ms. Gurpreet Kaur of Physical Sciences Department scored Ist position, Ms. Jyoti Garg & Ms. Swati Thakur of Chemical Sciences Department scored IInd position, and Mr. Aaqib Rehman of Civil Engineering Department score IIIrd position and got trophies. A consolation prize was given to Ms. Priyanka & Ms. Arti of Chemical Sciences. Hon'ble Vice Chancellor of I K Gujral Punjab Technical University Dr. Ajay Sharma gave away the prizes to the students. In his key note address to the students, he touched the various contemporary problems associated with environment and appealed the students to take lead in not only addressing these problems but be torch bearers and set examples for others. He emphasised that the contemporary environmental issues need interdisciplinary approach towards its solutions. He congratulated to the Department of Chemical Sciences on organising World Wetlands Day on campus and making students aware about various aspects of wetlands.

A field visit to Harike Ramsar site was also organised on 12th February, 2019 in collaboration with Punjab State Council for Science & Technology, Punjab State Department of Forests & Wildlife along with WWF-India. About 61 students and teachers of Department of Physics, Chemistry & Mathematics went to Harike where experts from WWF-India and Dr. Chander Parkash from Chemical Sciences apprised them about importance of Harike wetland. Students tried their hands on birds identification in various parts of the wetland. Dr. Parkash shared that how this wetland has been changed in last 20 years as he had been working on Harike for the last twenty years. He made them understand how the various microhabitats in the wetlands are

used by various animal & plants species for their existence especially fishes, various types of birds, turtles and mammals like otters, wild boar and jackals.

2. SCIENCE FEST 2019

Science is the basis of any country's progress; it is not necessary that science is the responsibility of a particular scientific community, Every common man can also create an interest in Innovation and Connect himself with science & Technology. National Science Day is celebrated on 28th February every year to honour great Indian Scientist C.V. Raman. He discovered famous Raman effect on 28th February 1928 and National Science Day is celebrated in memory of this discovery. Motivation of celebrating Science Day is to encourage young brains to take Science as their Career and excel in the field of Science. A Science fest was organised jointly by Department of Physical Sciences, Chemical Sciences and Mathematical Sciences at IKGPTU Main Campus on 5th April 2019 to celebrate National Science Day. District Education Officer M. S. Sidhu was Chief Guest for the event and inspired students to take interest in Science.

Dr. Rohit Mehra from Dr. B R. Ambedkar National Institute of Technology (NIT Jalandhar) and Dr. V.K. Garg from Central University Bathinda was the keynote speakers and shared their research experiences with students. Students express their idea related to Science in Poster making and Exhibition contests. Students of different departments also participated in a science quiz competition.
