

Subject: Grant of extension to complete Ph. D.

As per the approval of Hon'ble Vice-Chancellor, the extension as per following is granted to Ph. D students:

1. Those research scholars who are in their terminal year i.e seventh year/ eighth year (onetime special extension) and were supposed to submit their thesis in the Covid period between **20 March 2020 to 31 December 2020**, extension may be allowed for submission of their thesis till 30 June 2021 in line with UGC Public Notice No F.1-10/2020(CPP-II) dated 3rd December,2020 (Copy attached-A). No further extension to such students is permitted afterwards.
2. As per regulation after the pre-thesis presentation the scholar is generally required to submit final thesis within 3 months and further 3 months' extension was given with Rs. 1000/-.
For such backlog cases those who have not been able to submit the thesis during Covid period (**20 March 2020 to 31 December 2020**) is given one-time relaxation of last three months for submission of thesis by 31.3.2021 or his /her respective maximum duration end date whichever is earlier.
3. In continuation to Notification No IKGPTU/Reg/N/1416 dated 18.09.2017, it was further recommended that during the re-registration of the candidates, the credit difference if any, will have to be earned by taking additional course work for the fulfillment of total credit requirement.





NOTIFICATION

Sub: **Relaxation in Ph.D. rules 2010 of IKGPTU for Women and Persons with Disability (more than 40% disability) in the light of UGC Regulations 2016.**

As per UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Ph.D. Regulations, 2016 (In supersession of the UGC (Minimum Standards and Procedure for Awards of Ph.D. Degree) Regulation, 2009, notified in the Gazette of India (No. 28, Part III-Section 4) for the week July 11-July 17, 2009), the university hereby makes partial modification in the IKGPTU Ph.D. Regulations 2010 as under:

"Women and Persons with Disability (more than 40%) candidates shall be allowed to complete their Ph.D. Program in 8 years. In addition the women candidates shall be provided Maternity Leave/Child Care Leave once in the entire duration of Ph.D. for up to 240 days."

There will be no extension fee for the above said candidates.

This rule will take into effect from the date of issuance of notification of UGC Ph.D. Regulations, 2016 i.e. 5-May-2016.




