Item 1.2: To consider the updation of scheme and curriculum of M. Tech. Food Technology (Nutrigenomics)

Deliberations were carried out for finalizing M. Tech. first semester syllabus. The syllabus proposed by Department of Food Engineering was put before the members and following decisions were made:

- 1. Broad structure of the M. Tech. course will be as follows (annexure-1):
 - Core Courses: 38%
 - Inter-disciplinary and elective courses: 20%
 - Dissertation: 42%
- The syllabus was finalized with minor modification in three subjects out of seven (annexure-1).
- 3. The subject codes should be as per UGC guidelines. The subject codes were updated accordingly (annexure-1).
- 4. The interdisciplinary elective courses from the areas of Basic Sciences/ Management/ Languages/ Journalism and Mass Communication/ Other streams of Engineering/ Human Values and Professional Ethics can be selected by the students.
- 5. Minimum number of experiments to be conducted in the laboratory is ten out twelve specified in the syllabus (annexure 1).
- 6. It was decided that supervisor allotment will be done in the first semester itself.
- 7. The revised curriculum will be applicable from batch 2017 onwards.
- It is apparent that programme outcomes and course outcomes of M. Tech. Food Technology is as per UGC guidelines and will be formulated and put up in next BOS.

Item 1.3: To finalize the curriculum of B. Tech. Food Technology 7th and 8th semester

 The curriculum of 7th and 8th semester of B. Tech. Food Technology was finalized (annexure 2).

2. In addition, changes were done in the curriculum of B. Tech. semester third and fourth.

- 3. Minor modifications were also done in the scheme of 4th semester.
- 4. These minor changes in the 3rd and 4th semester were approved.
- 5. The modified syllabus will be applicable from batch 2017 onwards.

The meeting commenced with the formal introduction of the newly constituted Clinical Research BOS for campus programs. Chairman BOS took up the formal agenda items point wise.

Item 1.1: To welcome the new Board of Study

Chairperson welcomed the new board of studies with the brief introduction about the university, its working and the Department of Food Science and Technology. The members were informed about functions to be executed by the BOS and all members took keen interest in contributing towards all functions. The members were informed that Department of Academics, IKG PTU has issued guidelines regarding MSc. Skeleton for designing of the curriculum. The curriculum thus designed will in line with it.

Item 1.2: To consider the updation of scheme and curriculum of M.Sc. Clinical Research (Batch 2019-21 onwards)

The syllabus of MSc. Clinical Research for batch 2019-21 was finalized for first and second semester after the deliberations and suggestions of BOS. The board decided to adopt the syllabus prepared by previous BOS with necessary modifications and rectifications and the following recommendations have been made:

- The basic skeleton of MSc. Clinical Research study scheme was finalized by taking into consideration guidelines issued by Department of Academics, IKG PTU, and guidelines issued by UGC including generic electives and discipline specific elective courses.
- The course codes were assigned as per the guidelines issued by Director Office, Main Campus. The course outcomes of the course were prepared and the mapping of course outcomes and program outcomes was done.
- The first semester course "Fundamentals of Clinical Research" was revised. The module on intellectual property rights was replaced by pre clinical toxicity studies.
- 4. The nomenclature of first semester course "Pharmacology" was changed to "General Pharmacology" and the module on animal models of disease and toxicology studies was replaced with basic pharmacokinetics module.
- 5. The course "Ethics in Clinical Research" in first semester was removed as a separate course. The content of the course "Clinical Research Regulations" was enriched with

modules on ethics in clinical research. Accordingly, the nomenclature of the course changed to "Clinical Research Regulations & Ethics".

- In the first semester "Pharmacokinetics" course was removed and in its place, "Clinical Pharmacokinetics" was introduced.
- 7. The nomenclature of the course "Human Biology" was changed to "Fundamentals of Physiology". The nomenclature of the courses "Etiopathology & Pharmacotherapy-I" and "Etiopathology and Pharmacotherapy-II" was changed to "Pharmacotherapeutics-I" and "Pharmacotherapeutics-II" respectively.
- The content of the course "Pharmacotherapeutics-I" was revised. The content on pharmacoeconomics of this course was added to course "Pharmacoeconomics and Health Technology Assessment".
- 9. A new course "International Regulatory Affairs" was introduced in the second semester as discipline specific elective.
- 10. In the previous scheme the course type of "Ethics in Clinical Research" was discipline specific elective. In the new scheme this course was replace by "Intellectual Property Rights" course from the pool of second semester discipline specific elective course.
- 11. After detailed deliberation, it was decided to retain journal club course in the first, second and third semester of new study scheme. In this course, the students will be presenting literature, which would give them exposure to the latest advancements in the field and skill enhancement for better scientific communication and critical analysis of data.
- 12. Members deliberated that keeping in view the significance of documentation and scientific writing in the field of clinical research Medical Writing course is very important.
- 13. The ability enhancement courses, professional communication in the first semester and professional communication lab in second semester were included in the scheme. These courses will foster the ability to communicate both orally and in writing as per the demands of the profession.
