MINUTES OF MEETING

Meeting of BOS Architecture and Planning was held on 22nd July 2020 (Annexure-I). Few comments and concerns were raised by some board members which were communicated by email to Chairperson BoS. Subsequently, discussions regarding all the raised issues and fine tuning the scheme and syllabus of B.Arch 2019, BSc (Arch basics), M.Arch 2020 and M.Plan 2019 were continuously being held amongst core committee members in offline/online mode. An online meeting of core committee was then held on 28th August to finalize all the curriculas and the eligibility of each. Dr. Prabhjot Kaur chaired the meeting.

- Chairperson apprised the members that after BoS meeting comments from four out of 23 attendees were received.
 - a) Dr.Sandeep Dua Professor GNDU Amritsar through his email appreciated the efforts put by the team. He further suggested the following to be included in curriculum of M.Planning.
 - i. Conservation and Heritage should be incorporated
 - ii. Urban Design should be incorporated,
 - iii. Sustainability part should be incorporated in each and every subject

Core committee welcomed the suggestions and incorporated Conservation and Heritage topic in Urban Development Program subject in 2nd semester M.Planning, Urban Design in 3nd semester M.Planning scheme and Sustainability part has been included in majority subjects.


- b) Ar Shruti Kapur, Ar. Ruchi Lakhani, Ar. Bipin Malik raised following concerns over introduction of B.Sc (Architecture Basics)
 - i) According CoA 1983 norms there is already provision to impart degree of Bachelor of Building Sciences if anyone leaves the B.Arch course after completing stage-1
 - ii) Approval of CoA is required before commencing any such course.
 - iii) A course parallel to B.Arch, shall create confusion amongst the students

Core committee deliberated on the above mentioned concerns.

- BSc (Architecture Basics) was earlier envisioned as equivalent to mid level exit after completion of Stage-1 of B.Architecture. But consequent upon gazette notification dated 11th August 2020, Minimum standards of Architecture Education regulations CoA 2020 norms, provision of mid level exit after stage-I is discontinued (Annexure-II). Therefore BSc (Architecture basics) shall now be an UGC course.
- Supreme Court judgment dated 17th March 2020 which at page 40 clause 39 states that Section 37 of the Architects Act does not prohibit individuals not registered under the Architects Act from undertaking the practice of architecture and its cognate activities.

 Therefore approval of CoA for commencing this course is not required.
- BSc.(Architecture Basics) will be a 3 years UG program and shall be very beneficial for all those who intend to understand the fundamentals of architecture and serve in different roles of Building Industry. These graduates will also be able to diversify and excel in numerous other streams as per their interests and also will have multi entry/multi exit option with desired flexibility and autonomy as envisioned in NEP 2020 and policy document released by CoA in August 2020 (Annexure-III)
- iv) And the course of BSc (Architecture Basics) is already notified by IKGPTU vide notification IKGPTU/Reg/NF/54 dated 16th April 2020. BoS is required to provide the curriculum of same.
- e) The objections were also raised by these three members regarding the revision of syllabus in 2020 while it was revised in 2019 only.

It was discussed in the meeting of core committee that syllabus is revised keeping in view recommendations of 'New Education Policy'. Chairperson further apprised that in 2003 also immediate revision of syllabus was done for the syllabus revised in 2002, as it was required. No time line regarding revision of syllabus is given in any IKGPTU rules.



d) Ar. Bipin Malik raised the objections for introduction of Elective and MOOC courses.

After detailed deliberation and in light of NEP 2020, Core members strongly felt the need of introducing Open electives and MOOCS under choice based learning system, in line with UGC Gazette notification REGD. NO. D. L.-33004/99 dated 20 July 2016 and IKGPTU notification IKGPTU/RI7/NF/2096 dated 24 May 2019 regarding MOOC's (Annexure-IV).

- IKGPTU had notified policy regarding adopting MOOC courses for engineering course vide notification IKGPTU/RI7/NF/2096 dated 24 May 2019. It was discussed that approval for introducing MOOC courses for B.Arch, BSc (Arch Basics), M.Arch and M.Plan shall be sought from academic session 2020-2021 itself.
- 3. It was further discussed that syllabus of B.Arch 2019 (a CoA Program), BSc (Arch. Basics) 2020, M.Arch 2020 (Both UGC Programs) and M.Planning 2019 (An AICTE Program) are carefully designed and structured in line with NEP 2020 and various guidelines issued by statutaory bodies under MHRD. 20 out of 23 BoS members had approved the syllabus in a BoS meeting dated 22nd July 2020. Objections raised by only three members are placed in record as Annexure -V. Their concerns are thoroughly been deliberated. It was unanimously decided in the core committee that designed curricula along with eligibility criteriafor each of these courses shall be submitted for the approval of Academic Council.

- 1. The Committee deliberated on the detailed content of 7th to 10th-semester syllabus B. Architecture (B. Arch) 2019 scheme/Syllabus (with continuation to already approved scheme in BoS meeting held 29th June 2019). The 7th to 10th-semester syllabus was circulated dated 09/08/2021 which was discussed & deliberated upon the Board approved the syllabus with minor corrections. All suggestions received are incorporated. The complete detailed syllabus from the 7th to 10th semester is attached as Annexure-1.
- 2. The chairperson apprised the board member that as per the UGC guidelines any B.Sc. (UG) course having credits 140 or more should have a nomenclature of B.SC Honors and those courses having credits up to 120 should have the nomenclature of B.SC only. (UGC guidelines are attached with the relevant portion highlighted). Hence the Committee recommended that the nomenclature of B.Sc. (AB) be changed to B.Sc. (H) Architecture Basics a case in this regard shall be put up for approval and revised notification. Annexure-2.
- 3. The Coordinator Board of Studies (Architecture) introduced the course and scheme of the syllabus of B. Arch 2021 which had been prepared in the light of NEP 2020/ UGC Board Guidelines and the COA (Council of Architecture) Minimum Standard Architecture Education -2020. The salient feature of this scheme especially to MOOC's Courses and other courses directed by IKG PTU had been highlighted by her. But it was conveyed by the representative of the affiliated institutes that they have decided to continue with the B. Arch 2012 scheme only, till the complete confensus on 2021 is arrived upon.

The Chairperson formulated the following team to work on the B. Arch 2021 scheme and syllabus and to make a consensus:-

4. The M.Arch (AER) is offered in Mohali campus - Il since January 2014. Despite 20 regular seats, the takers of M. Arch in regular mode are less as compared to inquires for the part-time course. MSAE regulations 2020 of CoA highlight that the M. Arch (AER) course is considered in either mode i.e. Full

time as well as Part-Time for the faculty recruitment. (relevant portion attached as **Annexure-3.**) As both the modes are acceptable to CoA it is recommended to offer the M.Arch in 03 distinct modes for the benefit of students and to bring it in line with NEP 2020 guidelines:

- I. Regular mode 02 years (PG Diploma Exit after 01 years)
- II. Part-time mode 03 years (PG Diploma Exit after 1.5 years)
- III. Mix Mode PG Diploma after 01 years of study in regular mode and M. Arch (AER) in another 1.5 years in Part-Time mode, the second for in part-time mode.

Discussions were held on the issue and it was decided that the M. Arch (AER) should be offered from Mohali campus - II in all three distinct modes from 2021. All the suggestions made are incorporated & attached as Annexure - 4

- 5. Issue of thesis load calculation was taken up. All the members agreed upon a load of 1 period / per student/ per week for thesis guides as well as for overall thesis guides/ senior faculty and mentors.
- 6. Notification for the distribution of marks for evaluation of M.Arch and M. Planning dissertation is required to be issued. The scheme of distribution of marks for the same has been deliberated upon and placed as Annexure 5 for approval. Consent upon approval case shall be put up for notification of same.
 - 7. Issue of syllabus constitutional law UC/BARCH-409/19 was brought to light by members. The syllabus submitted earlier was very comprehensive and required revision. The revised syllabus was put before the members for consideration of revision. All the members gave their go-ahead regarding the same. Annexure 6
 - 8. Dr. Fuzail Jawaid (AP) has raised the issue of appropriate naming of the 'Department of Architecture' to 'Department of Architecture, planning, and Design' in view of planning courses already offered at M.C II and upcoming Design courses. It has been informed by the Chairperson that the case in this regard is already submitted as decided in the 22nd January 2021 BoS meeting Annexure 7. The BoS deliberately once again and reinforced to rename the department as a department of "Architecture Planning and Design" the case shall be followed up for approval and issued the notification in this regard.

- 6. To Finalize the syllabus of 1st and 2nd semester of M. Arch (Architecture Education and Research)
- 7. Any other point with the permission of the Chairman.

Chairperson welcomed the members and thanked them for sparing their valuable time for updating the curriculum of courses of IKGPTU Mohali Campus-II in particular and promoting the quality of architecture education in general.

Thereafter the agenda already issued was taken for discussion and after detailed deliberations following decisions are taken:
