NCC TRAINING CAMP : 8-sep-2021 to 17-sep-2021

NCC stands for National Cadet Corps that provides basic training to the Cadets of schools and colleges for different wings Army, Navy and Air Force. It aims to groom Cadets into disciplined and patriotic citizens. NCC cadets are given the opportunity to participate in a host of adventure activities including Mountain Treks and Expeditions, Trekking, Parasailing, Sailing, Scuba Diving, Kayaking, Camel safari to hone leadership skills and enhance their character qualities. Various NCC Camps are held such as Combined Annual Training Camp (CATC), Basic Leadership Camp (BLC) Pre-Republic Day Camp (PRDC) , Advanced Leadership Camp (ALC), Course at Himalayan mountaineering institute Darjeeling, Para Troopers Camp (PTC), National Integration Camp (NIC), Army Attachment, Republic Day Camp (RDC), Hiking and Trekking Camp, Thal-sainik camp (TSC). The main Focus of NCC is on instilling discipline in the souls of the cadets, besides fostering healthy competition for the ranks, while keeping the greater interest of the nation in mind to create prospective officers for the Armed Forces. The National Cadet Corps is the only organization of its kind, which imparts Leadership, Discipline, Integration, Adventure, Military, Physical and Community Development training to over 15 lakhs youth of the country.

A summary of all the activities carried out by NCC unit of 21 PB BN NCC Kapurthala year 2021-22 are showcased.

A 10-day NCC combined annual training Camp (CATC-42) was organized by 21 Punjab BN NCC Kapurthala at I.K. Gujral Punjab Technical University. As many as 200 Cadets from various schools and colleges participated in the camp. Cadets were trained in drill and rifle shooting. They were also given exposure in cultural activities as well as in Sports.

First day was the inauguration day in which our commanding officer Col. Vishal Opal gave a powerful speech that motivated the cadets. The Aim and Objectives of NCC were cleared and also, he briefed us about the schedule and details of camps.

From the very next day the given schedule was followed by all the cadets. Schedule was very surprising for cadets, because it was fully packed with drills and lectures. The lecture was held daily according to schedule which including weapon training, Map reading, technical data of Rifles, Patrolling , Games and some other ground training that are used in Armed Forces.

On the other hand to enhance physical activity and develop leadership skills some Sports activities were held like 400M race, Volleyball and Basketball Tournaments. In which cadets participated with great enthusiasm.

On the 3rd day of camp we learnt how to assemble and disassemble a 0.22 rifle and how to clean it. We have been also briefed about Infantry, Artillery and Armoured and

In the evening 400m race competition was held in which 10 (SU) and 6 (SW) cadets participated and showed their spirit and hard work.

In this competition two SDs JAGROOP SINGH and ADARSH KUMAR, Cadets of IKGPTU got 1st Position and 2nd position respectively. From SWs all the three position holders were from IKGPTU, Komal Bansal, Archana and Sanjana got 1st position, 2nd position and 3rd position respectively. At the end of event winners were awarded by the Commanding Officer Col. Vishal Opal with customised Cups and medals.

On 4th day in morning we had lectures on assembling and disassembling of 7.62mm Self Loading Rifle and its characteristics, Indication of Landmark and and later in evening we had a public speaking activity in order to improve communication skills between the Cadets. Raghav Kumar from I.K.G. PTU gave lecture on Cyber security and how we can spread awareness in common people preventing thief and online fraud. Another cadet Ridham Saini delivered a powerful speech on geopolitical war.

On the 5th day, we had a lecture about field signal which included the theory as well as ground practice. We also learnt how to load and unload .22 Rifle and its firing position with hand on practice and in the evening we also had a seminar on stress management .On the same day tials for volleyball and basketball match were taken.

On the 6th day of camp a volleyball tournament was held in which 14 players participated. The teams were divided into A and B names. The Match turned out to be very interesting. It was played in three sets in which both the teams showed their full efforts to beat each other, but at last the team A won. The winners and runner up were awarded by Commanding Officer Col Vishal Opal by giving medals to winners and NCC shirts to Runner up

teams. In the evening an awareness lecture was given by Rajveer Singh Rana (Army officer) & Raghav Kumar (student of I.K.G PTU) on Cyber-security and its importance in Army.

On 7th day of Camp a basketball Competition was held in which 14(SD) and 14(SW) cadets participated. The same enthusiasm and effort were seen among the Cadets.

The girls team B was commanded by Garima Chauhan from IKGPTU and Team A was commanded by Harmanpreet Kaur from IKGPTU. The boys team were headed by Deepak Kumar from IKGPTU (Team A) and Raghav Kumar from IKGPTU (Team B). From boys team B won and in girls side too team B won.

On 8th day in morning the half of the Cadets were taken to shooting range around (6:15 AM) where the Cadets were given the opportunity to fire from 25 m away target by .22 Rif and the left Cadets in camp had their regular classes and drill .

On 9th day the remaining Cadets were taken to the shooting range and the other Cadets attended the regular lectures and drill. The camp fire was organised In the evening which included cultural program which was organised by the Cadets who showcased their skills and talents in extra-curricular activities. Cadets performed bhangra, group dance, poetry, singing, and shared the 10 days experience of camp.

On 10th day the closing ceremony was held and a closing speech was delivered by the commanding officer Col. Vishal Opal Sir. In the ceremony best shooters and best cadets were awarded with the medals. In shooting Jashandeep kaur and Harmanpreet kaur of IKGPTU got 1st and 2nd position later After that two best cadets were announced from SW and again the same two SW were awarded. From SD Jagroop Singh from IKGPTU and kunal singh. After this a beautiful present was given to Commanding officer and their team for their efforts and hardwork to successfully organising the Camp. The remaining formalities of the Cadets were completed and they all were sent back to their homes and colleges.

Jalandhar/Kapurthala: The Constitution Day was celebrated with full devotion and morality at I.K. Gujral Punjab Technical University (IKG PTU) on Friday. University Registrar IAS Jaspreet Singh attended the function as the chief guest. Deputy Registrar Dr. Sandeep Mehmi delivered the special speech of the day. During the event, all pay respect to the father & the architect of the Indian Constitution, Dr. Babasaheb Ambedkar ji. At the same time, making the copy of the Preamble of the Constitution in public in a big way, everyone was called to put it in their offices or work place.

Deputy Registrar Dr. Sandeep Mehmi, who was the speaker, said that every year 26 November is a very special day for every Indian citizen. This is the day when the Constituent Assembly of the country duly adopted the existing Constitution. It is the Constitution which makes us realize the feeling of a free citizen of a free country. While the Fundamental Rights given in the Constitution give us our rights by becoming our shield, we also remind us of our responsibilities in the Fundamental Duties given in it. He called upon all the students present from the stage to read the speech given by Babasaheb ji a day before 26 November.

According to the facts kept from the forum, in the year 2015, as the 125th birth anniversary year of Dr. Ambedkar ji, the architect of the Constitution, the Ministry of Social Justice and Empowerment declared the Central Government's decision to celebrate this day as 'Constitution Day', was notified. This day is celebrated to promote the sense of respect among the citizens for the constitutional values.

University Registrar IAS Jaspreet Singh read out the Preamble of the Constitution. During this, everyone present in the meeting took an oath to abide by the Constitution. On behalf of University administration authorities, the Registrar, congratulated everyone on the Constitution Day.

Punjab Skill Development Mission Society (PSDM), a nodal agency of the Government of Punjab for its Skill Development Mission, represented by Mission Director having its office at S.C.O 149-152, Level 2, Sec 17 C, Chandigarh (hereinafter referred to as "**FIRST PARTY**" which expression shall, unless repugnant to the context or meaning thereof, mean and include its successors and assigns);

AND

I.K. Gujral Punjab Technical University (PTU), a nodal agency of the Government of Punjab established by an Act of State Legislature, represented by Dean (Planning & External Programmes) having its office at Jalandhar-Kapurthala Highway, Kapurthala, Near Pushpa Gujral Science City, Jalandhar (hereinafter referred to as "**SECOND PARTY**" which expression shall, unless repugnant to the context or meaning thereof, mean and include its successors and assigns);

AND

ICICI Foundation for inclusive growth (ICICI Foundation), a charitable trust registered at Chennai, Tamil Nadu vide a Trust Deed dated January 04, 2008 and having its office at ICICI Bank Towers, Bandra Kurla Complex, Bandra East, Mumbai 400051(hereafter referred as "**THIRD PARTY**" which expression shall, unless repugnant to the context or meaning thereof, mean and include its successors and assigns), of the other Part.

BACKGROUND

- A. First Party recognizes the value of skill development initiatives for the community and are willing to support and collaborate with individuals, institutions, trusts, corporate bodies and any other such entities that administer and run skill development initiatives for the lesser privileged youth in the state of Punjab ("State") and thereby enabling them to participate in the growth and economic development of the State.
- B. Second Party has the mandate to set up centres of excellence in emerging technologies and for promoting training, research and development in these areas. The University has undertaken the task of training students to help in the development of skilled manpower in this sector in the country in general and in the state, in particular.
- C. Third Party is a public charitable trust, set up with the objectives as set out in the Trust Deed dated January 04, 2008, which inter *alia*, includes catalyzing and accelerating inclusive social and economic development through empowerment of poor by integrated action in the diverse fields connected to the society to augment India's inclusive growth process. As a part of achieving such objectives and to further its initiatives towards education and livelihoods, Second Party has institutionalized the ICICI Academy for Skills that provides skill training and vocational training to young unemployed school and college dropouts which may lead towards their self-employment or wage employment.

- D. The Parties had earlier collaborated with each other vide a Memorandum of Understanding dated February 17, 2016 for setting up a centre of ICICI Academy for Skills at Mohali, Punjab, hereinafter referred to as the 'Academy'. This non- financial Agreement is entered between the First Party, Second party and third party for a term of five years.
- E. The Parties are desirous of continuing the said collaboration and continue providing technical and skill development training through the Academy in accordance with the terms and conditions as agreed upon in this MoU. The MoU shall be effective from the expiry of the earlier MoU between the parties.

1. OBJECTIVE /PURPOSE OF MOU

The parties hereto mutually agreed upon to continue their collaboration for operating the Academy to train the lesser privileged youth in the State ("Trainees") and to assist them to seek employment (either by wage employment or self-employment) in the relevant field. The Parties have further agreed that the Academy will strive to train 1600 candidates of Punjab annually and that the Academy will be on a non-residential basis, i.e. it shall not provide lodging (hostel) facility to the candidates. To further the aforesaid objective, this MoU sets out the terms and scope of collaboration between the parties.

2. SCOPE AND INTENT:

The scope of this document is valid for three years from the date of signing. The duration of this MOU can be extended by mutual consent of all the three parties.

3. PROGRAM DETAILS:

The selection criteria of the Trainees (age, education and social economic background) and the operational parameters, including the course(s) to be offered at the Academy, shall continue to be mutually decided in writing by the Parties keeping in view the market demand and the local factors and the changes therein. The training shall be held physically but in case of any restriction imposed/set in by Government (for ex. COVID, Pandemic) the theoretical part can be executed in online mode.

The specific responsibilities and obligations of each Party and other relevant details are as set out in the **Annexure I** attached herewith. The list of courses being offered at the Academy is listed in **Annexure II**.

4. REPRESENTATIONS AND WARRANTIES

Each Party hereby represents and warrants that it has all requisite power and authority to execute this MOU and to perform its obligations hereunder. The execution and delivery of this MOU and the performance of this MOU will not constitute a breach or constitute a default or a breach of any agreement entered with any third party and it will perform its obligations and fulfill its responsibilities under this MOU in a manner that complies with all applicable laws.

5. CONFIDENTIALITY

Neither the first party nor the second party and the third party shall disclose during the term of this agreement or thereafter to any third party any information, course materials or make public the documents, materials, equipment's, diagrams etc. of joint course provided by first, second and third party.

6. TERMINATION

Any Party desirous of terminating this MOU shall forthwith provide written notice of 120 days to the other Parties. However, the Parties shall ensure that termination of this MoU is

not effected in the middle of ongoing training batches at the Academy except that either Party can forthwith terminate this MoU in case of breach of any of term of this MoU by the other Party.

7. MISCELLANEOUS

- A) Unless otherwise agreed in writing by all, each party shall bear its own cost in connection with effecting the terms and conditions to this MoU.
- B) Each party may request changes to this MoU. Any changes, modifications, revisions, amendments to this MoU which are mutually agreed upon and between all the parties shall be incorporated by the written instrument, and effective when executed and signed by each party.
- C) Relationship of each party under this MoU is that of independent entities and nothing in this MoU shall, or shall be deemed to constitute or place them in fiduciary relationship, any other relationship of trust or confidence, partnership, employer-employee, agency or joint venture relationship and no party shall have the right to agree to obligations on behalf of any other Party in any manner.
- D) For effective implementation and monitoring of MoU, each party shall designate a nodal officer. The nodal officer from each party shall be proactive, have good English written and oral skills, shall have email access and shall be able to get things executed.
- E) Any dispute, differences, claim or question of interpretation of any nature arising between the Parties with respect to this MoU as to the respective rights, claims, liabilities and obligations under this MoU, including any question regarding its existence, validity or termination which is not resolved by amicable settlement shall be referred to and finally resolved by arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996 or any statutory amendment thereto. The Parties shall mutually appoint a sole arbitrator to conduct the arbitration proceedings. The venue of such proceedings shall be at Chandigarh and the language of arbitration shall be English. The award of the arbitration shall be final and binding on the Parties. The costs of Arbitration shall be borne in such manner as the arbitrator may direct.
- F) Force Majeure Clause.
 - a. For the purposes of this MoU, "Force Majeure" means an event which is beyond the reasonable control of a Party, is not foreseeable, is unavoidable and not brought about by or at the instance of the Party claiming to be affected by such events and which has caused the non-performance or delay in performance, and which makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other extreme adverse weather conditions, strikes, lockouts, pandemic and pandemic induced lockdown or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by Government agencies.
 - b. Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or by or of such Party's Sub-Consultants or agents or employees, nor (ii) any event which a diligent Party could reasonably have been expected to take into account at the time of the conclusion of this MOU, and avoid or overcome in the carrying out of its obligations.

8. NON-BINDING

This MOU is non-binding in nature herein and the parties agree that the execution of this MOU shall not constitute any undertaking by each party to mandatorily perform the transactions hereunder. This MOU does not impose legal or financial obligations on each

Responsibilities of First Party:

PSDM and IKG PTU recognize the value of skill development initiatives for the community and are willing to support and collaborate with individuals, Institutions, Trusts, Corporate bodies and any other such entities that administer and run skill development initiatives for underprivileged youth in the state of Punjab;

ICICI Foundation is setup as a public charitable trust, with ICICI Bank Limited as the settler, with the object of *inter alia*, catalyzing and accelerating social and economic inclusion through empowerment of poor for participating in and to the benefit from the Indian growth process through integrated action in the fields of primary health, elementary education, financial inclusion and sustainable livelihoods. Further to its initiatives towards education and livelihoods, ICICI Foundation has set up the ICICI Academy for Skills that provides skill training and vocational training to young unemployed school and college dropouts;

ICICI Foundation recognises the sincere concerns and efforts of the Government of Punjab through its departments and agencies to provide support towards skill development initiatives targeted at the under-privileged and unemployed youth sections of the society and wishes to collaborate with its relevant departments for instituting and administering skill development initiatives.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS

1. SCOPE AND INTENT

The parties hereto have mutually agreed upon collaborating towards provision of skill development training to youth to improve their livelihood prospects through self-employment and wage employment, by setting up a training centre. The training centre shall be called 'ICICI Academy for Skills - An Initiative of ICICI Foundation for Inclusive Growth in Partnership with Government of Punjab', hereinafter referred to as "Academy") during the validity of this MoU, including any extensions to or renewals of the same.

Skill development training programmes offered at the Academy shall be specially designed and developed for youth. The Academy shall provide free-of-charge residential and/or non-residential skill development training in courses listed in Annexure I. The courses may be reviewed from time to time as may be mutually agreed upon between the Parties, keeping in view the market demand.

2. PROGRAMME RESPONSIBILITIES AND OBLIGATIONS

The specific responsibilities and obligations of each Party, including the deliverables and timelines in relation to this MoU are as detailed in Annexure II herewith.

3. REPRESENTATION AND WARRANTIES

- a. Parties to this MoU represent that the purpose of the MoU is in line with their respective objectives;
- b. Parties further state and submit that they have taken all the necessary internal and external permissions and obtained all requisite licenses, permits as may be required to implement this MoU;
- c. ICICI Foundation may at its own discretion, either directly or through independent third parties, monitor and audit the functioning of the Academy;
- d. The Parties shall abide by the agreed terms and shall exercise diligence, high ethical and professional standards in rendering the services under this MoU;
- e. The Parties are solely responsible for implementation of the obligations under this MoU in compliance with all employment, statutory, taxation and regulatory obligations applicable to it and its personnel;
- f. The Parties agree and undertake that it shall not carry out or indulge in any activities that would be prejudicial to the interest, reputation of the other Parties and any of the activities they conduct;
- g. Each Party represents to the other Parties that this is a non-financial collaboration and they have not and agree that they shall not, in connection with this MoU, make any unlawful payment or transfer, directly or indirectly, to any personnel of the other Parties or any other person.
- h. Each Party represents and undertakes that it and its employees, agents, officers or representatives, shall not receive, purport to receive or seek, directly or indirectly, any payments or transfers in kind of any value from eligible candidates and other persons they counsel or mobilize for the purposes of this MOU and for acceptance into the Academy.

4. FORCE MAJEURE

None of the Parties shall be liable for any failure or delay in performance under this MoU resulting directly or indirectly from causes beyond their reasonable control due to act of God, war declared, civil or political disturbance, lock-outs, Industry wide labour strike, drought, floods, fire, theft, accidents and other exceptional circumstances. In such a situation, a Party's liability ceases under this MoU and the Parties shall discuss the course of action to be taken afterwards. In the event of a force majeure event as aforesaid, the Party affected by such event, shall forthwith provide notice and details of such event to the other Parties.

5. INTELLECTUAL PROPERTY RIGHTS

- a. ICICI Foundation is hereby granted the right to use the reference of the name and association of PSDM and IKG PTU for the purpose of promoting the initiative and

activities under this MoU through public advertisements through various means including print, electronic, radio / audio-visual, banners / pamphlets / posters, wall painting, fascia / sign boards, etc. during the tenure of the MoU.

- b. ICICI Foundation will undertake to brand the premises provided for running the Academy and residential facilities under this MoU as "ICICI Academy for Skills - An Initiative of ICICI Foundation for Inclusive Growth in Partnership with Government of Punjab".
- c. All Parties acknowledge and agree that they shall not use in any manner the brand, name, logo or other intellectual property of the other Parties nor permit any third party to use other Parties' intellectual property without the prior written permission and subject to any conditions stipulated for use of such intellectual property.

6. CONFIDENTIALITY

- a. All Parties hereby unconditionally agree and undertake that they shall not disclose the terms and conditions of this MoU to any third party without prior written consent of the other Parties. All details, documents, data, procedures, financials, papers and statements communicated by the disclosing Party under this MOU will be treated as confidential by the receiving Parties and shall not be disclosed in whole or in part to any person without the prior written permission of the disclosing Party other than as may be necessary for the due performance of their obligations hereunder.
- b. Nothing contained herein shall be construed as granting or implying any transfer of rights (including license and intellectual property rights) to either Party in the confidential information or other intellectual property protecting or relating to the said arrangement.

7. TERMINATION CLAUSE

This MoU shall become effective from the date of its signing up to a period of five years. The MoU shall continue to remain in full force and effect unless otherwise terminated by any Party as is provided herein. The termination and exit strategy applicable to this MoU is detailed in Annexure II herewith.

Provided that in the event of any Party committing a breach of any of the provisions hereof, the other Parties may forthwith, through notice in writing, terminate this MoU, without any liability whatsoever arising from such termination.

8. GOVERNING LAW AND JURISDICTION

The provisions of this MoU shall be governed by and construed in accordance with Indian law. The Parties undertake to resolve any unforeseen events and all disputes arising out of or in connection with this MOU, including any question regarding its existence, validity or termination, through amicable discussions between the Parties.

9. MISCELLANEOUS

Each Party will be solely liable for performance of the obligations and activities assigned to it under this MoU, including any third party claims arising from each Party's actions or omissions during the term of this MoU.

It is the intent of the Parties that no payments or transfers of value shall be made which have the purpose or effect of public or commercial bribery or acceptance of or acquiescence in extortion, kickbacks, or other unlawful or improper means of conducting the services, if required.

In the event of either Party committing a breach of any of the above terms and conditions contained herein then the other Party may forthwith by notice in writing to the other Parties terminate this MOU without any liability of any sorts whatsoever in respect of such termination.

The Parties acknowledge and agree that they are acting for the limited and exclusive purpose of this MoU solely on a principal-to-principal basis and this does not amount to the Parties being deemed as a servant or employee or partner or joint venture or affiliate of the other. The Parties shall have no authority to bind the other in any respect whatsoever and shall not hold itself out as owned by or associated with the other Party. None of the employees, workers or other man power of each Party shall be construed or deemed to be the employees of the other Parties at any time.

Each Party understands and acknowledges that they shall not assign or otherwise transfer its rights or obligations under the MoU, in whole or in part, without the prior written consent of the other Parties.

Any aspect of the collaboration that has not been detailed in this MoU may be agreed in writing by the Parties based on mutual discussion.

This MoU constitutes the final and entire understanding between the Parties with respect to this collaboration and any amendments or waiver to this MoU shall be in writing and signed by all Parties.

Responsibilities of PSDM & IKG PTU:

- Providing free of charge space: Making available physical space in good repair and condition, to the extent of about 65,000 sq. feet built-up area, free of charge, at a mutually agreed location within the State, as per the details below, for the duration of the proposed Partnership:
 - Academy (annual capacity of 2,000 students)
 - For Training centre & labs: 20,000 sq. feet approximately
 - For Hostel & common area: 45,000 sq. feet approximately
 - Total: 65,000 sq. feet approximately
- Sourcing: Mobilising prospective youth from underprivileged backgrounds in the 18 to 30 years age-group and enrolling them for training at the proposed Academy.
- Placement assistance: Facilitate ICICI Foundation's efforts for placement of students upon successful completion of training.

Responsibilities of ICICI Foundation:

- Operations: Setting up and running the Academy, including providing for moveable assets
- Placement assistance: Providing placement opportunities to students upon completion of training, on a best-effort basis with assistance from State Government
- Expenses: Undertaking the operating expenditure for the Academy for the tenure of the MoU, including expenditure on:
 - Boarding and lodging of students in the hostel
 - Provision of trainers and training materials
 - Medical and personal accident insurance and uniforms for the students
 - Housekeeping and Security of the Academy
 - Travel by and conveyance for the Academy personnel
 - Electricity, water and telecommunications, including Internet

Joint responsibilities:

- Certification: Upon completion of the training, the students shall be jointly certified by PSDM, the respective Knowledge Partner & ICICI Foundation.
