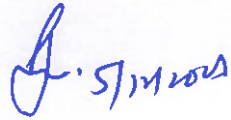

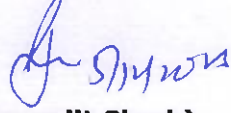

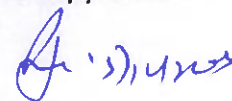
- Implementation of mapping code of all subjects for the compatibility of web-based Module and offline Module of EDP Cell.

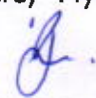

## Policy document on e-governance

Examination department is working in fully automated environment. Login Ids are created at [www.ptudocs.com](http://www.ptudocs.com) to fasten the facilitation of stakeholders with transparency, confidentiality and integrity. The main branches of Examination department are Conduct, Secrecy and Result Branch. The policy that prevails during functionality of each department using e-governance is as below:

### **Conduct Branch: Conduct of Examination**

- The first step is generation of Roll number to the eligible candidates online. Then Semester upgradation of already studying students is done by the respective HOD of the department for already studying students after confirming their upgradation from previous semester to next semester. This option is provided at [www.ptudocs.com](http://www.ptudocs.com) in the login IDs of concerned HODs. Those students who fulfilled the attendance norms (minimum 75% and clear the previous semester) are upgraded and only upgraded students can fill their examination forms online.
- If a student is drop out or detained and is not upgraded by the HOD as per norms, then he/she is not eligible for filling the examination form. Examination forms of regular semester and reappear subjects as per declared result records of university are available in Login IDs of students. The students filled the subjects and deposited the notified fee by the University via online mode. The exam forms are confirmed by the concerned HODs after verifying No Dues. The students those are finally confirmed by the HODs are issued the admit cards as per notified schedule. Date sheet is also notified via the login Ids of stakeholders.
- If a candidate, after admission to an examination is found an illegal act or an act of serious indiscipline, in such cases the Login Ids of students are blocked for notified time as per norms of the University
- Online module is created for paper setters as per the university norms for paper setters. Question papers are transmitted online using a secure environment and student attempt the question paper within allotted time.
- For offline examinations, An examination centre set up in a college/institution only if the minimum number of examinees is 300 in that examination. The maximum strength of examinees allocated to an examination centre is 500. In institutions where the number of examinees is more than 500, more than one examination centres can be set up. Local Controller, Assistant to Controller, Superintendents, Printing Cell Coordinators, Invigilators, Observers, Flying

Staff are deputed for the fair and smooth conduct of Examinations. One teacher shall be appointed for the supervision as Invigilator for 30 candidates. Honorarium of all the deputed staff is processed via the online module.

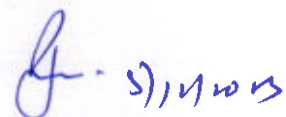
- For Online examinations, Eligible students who got the admit cards can download the question paper and upload the answer sheets from the respective login IDs.
- For Practical Examinations, there shall be two examiners for each Practical/Viva Voce Examination at each examination centre, one internal and one external. The external examiner must have minimum of three years of teaching experience in a recognized college/University. Awards are being uploaded from the concerned faculty login ID.
- Cut list, Attendance Sheets, forwarding memo and award lists are generated on the basis of online submitted Examination Forms. Absentee Record, daily report and correspondence with Exam Centre staff occur through concerned login ID.
- Answer sheets are packed and then submitted in Established Nodal Centres and Nodal Centres submit the packed answer sheets to Secrecy Department.

***Secrecy Branch: Evaluation of Answer Sheets***

- For offline Examination, the answer sheets are evaluated at respective PIT/Constituent Campuses. After evaluation, the answers sheets are shown to the student by respective Class Incharge and after addressing the grievances/Queries regarding evaluation then final awards are sent to Result Branch for declaration of results.
- For online Examinations, handwritten Answer sheets are uploaded by the students in login IDs which are made available to the respective subject teacher of the PIT/Constituent Campuses. The evaluated answer sheets are shown to the students by respective Class Teachers. After addressing the grievances/Queries regarding evaluation then final awards are sent to Result Branch for declaration of results.

***Result Branch: Processing of Results and Document delivery***

- After processing of awards, the result of students is declared in Institute and Student Login Id as per norms approved by the University.
- Generation of result tabulation, Details Mark Card, Provisional Degree Certificate, Original Degree Certificate, Migration Certificate and Transcripts are delivered Online in the respective login IDs.

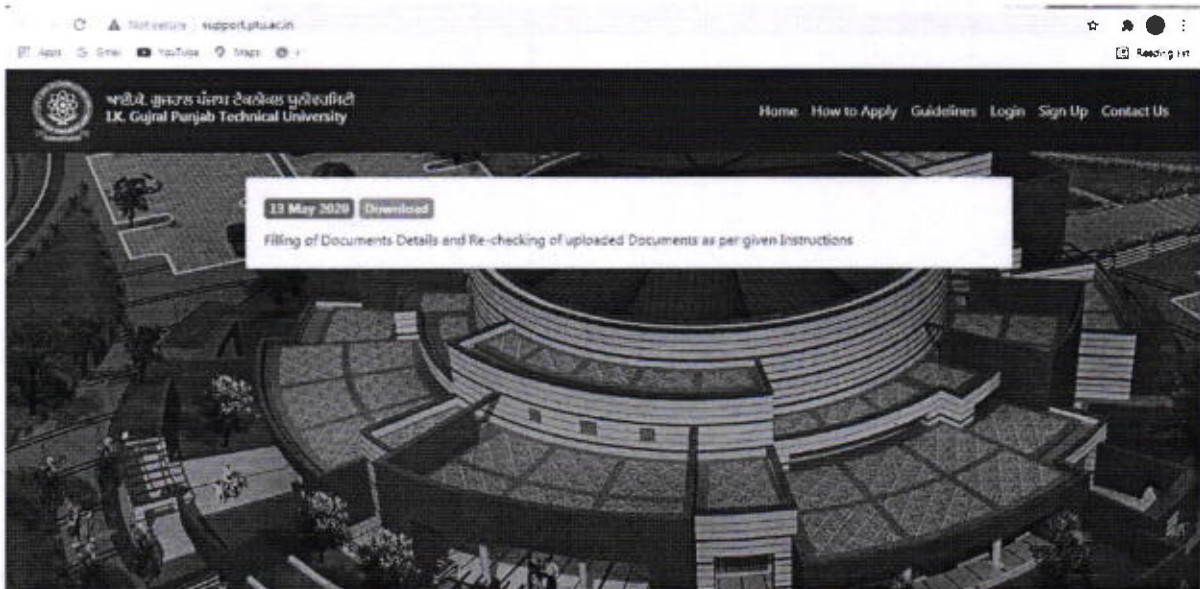
