2. Corrigendum/Addendum /Corrections/Notice, if any will be published on the website.
3. All fees like cost of tender document (Non-refundable) and earnest money deposit (EMD) shall be paid through ONLINE mode (IPG, Net Banking, NEFT/RTGS) only.
4. Bids must be submitted online through e-portal etender.punjabgovt.gov.in before the time specified in the above table (as per system clock). Department/Service provider does not take any responsibility for the delay caused due to non-availability of internet connection or network traffic for online bids.
5. Bidders shall up load scanned copy of all the papers i.e. proof of cost of tender document, earnest money deposit (EMD) and other documents as mentioned in the subsequent pages.

Online tenders are invited from Taxi operators for supply of Scorpio /Innova/ Xylo/ Tavera/Qualis/ Tata Sumo/Indica/Indigo/ Swift/Vista/ Tata 407/Tata ACE/Mahindra or equivalent Air conditioned and Non Air Conditioned Diesel driven/Petrol driven and on daily/monthly requirement basis for a period of **one year**, which can be extended for another term on the basis of satisfactory performance. However, total period of this service cannot exceed **three years** from the date of issuance of first work order.

The work is to be performed strictly as per special terms and conditions mentioned in the documents forming part of this tender. The special terms and conditions specific to the contract have been mentioned in Part-II of Annexure-II. General Guidelines

1. The Commercial Bid only submitted by online and not to send hard copy. Commercial bids of only those tenderers will be opened who will qualify technically.
2. Technical bid Performa to be filled on line.
3. Technical bid will be opened on the due date and time as notified, in the presence of the vendors present with authorization letter from the respective company/firm.
4. The bidders who qualify the technical bid, will only be informed regarding opening of financial bids. The financial bids will be opened on the due date and time as intimated, in the presence of the vendors present with authorization letter from the respective company/firms.
5. Rates should be inclusive of all taxes GST/govt levi etc.
6. The EMD/Performance security is liable to be forfeited in case the supplier fails to execute the order in time.
7. IKGPTU shall not be responsible if it is not possible to up load / submit the tender online due to any fault or malfunctioning of the internet / e tender site.

GENERAL TERMS AND CONDITIONS

Sub : TENDER FOR HIRING OF TAXIS (Subject Details as on page no.4 in first paragraph)

1. **Parties:** The parties to the Contract are the contractor (the tenderer to whom the work has been awarded) and I.K.Gujral Punjab Technical University.
2. **Addresses:** For all purposes of the contract including arbitration there under, the address of the contractor mentioned in the tender shall be final unless the contractor notifies a change of address by a separate letter sent by registered post with acknowledgement due to the Registrar, I.K.Gujral Punjab Technical University, Jalandhar-Kapurthala Highway, Kapurthala, Punjab, PIN 144603. The contractor shall be solely responsible for the consequences of any omission or error to notify change of address in the aforesaid manner.
3. **Earnest Money:** (As mentioned on the Page no.2)
 - 3.1 No request for transfer of any previous deposit of earnest money or security deposit or payment of any pending bill held by the University in respect of any previous work will be entertained.
 - 3.2 Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bank guarantee/demand draft will be forfeited.
 - 3.3 The tenders without Earnest Money will be summarily rejected.
 - 3.4 The contractor has to furnish Security Deposit @ 5% of the award value (including EMD) of the work awarded to him. It is the prime responsibility of Contractor to deposit the amount before commencement of work. The Security Deposit shall be in the form of demand draft in favour of I.K.Gujral Punjab Technical University. EMD of the successful contractor will be converted into security deposit and total amount of security will be 5% of total award value. If contract is awarded less no of locations his security deposit will be limited to 5% of the award value of the work awarded to him. In case, EMD deposited by him will be more than 5% of his award value, excess amount will be refund to him.
 - 3.5 The Security Deposit can be forfeited by order of the Registrar, in the event of any breach or negligence or non-observance of any terms/condition of contract or for unsatisfactory performance or for non-acceptance of the work order. On expiry of the contract, such portion of the said Security Deposit as may be considered by the Registrar, I.K.Gujral Punjab Technical University sufficient to cover any incorrect or excess payments made on the bills to the firm, shall be retained until the final audit report on the account of firm's bill has been received and examined.
4. **Signing of Tender:**

The tenderer to sign all the pages of tender document and upload on the portal. He should have authority to do so.

The tenderer should sign and affix his/her firm's stamp at each page of the tender and all its Annexures as the acceptance of the offer by the tenderer will be deemed as a contract and no separate formal contract will be drawn. NO PAGE SHOULD BE REMOVED / DETACHED FROM THIS TENDER DOCUMENT.

- 4.1 In case of partnership firms, a copy of the partnership agreement, or general power of attorney duly attested by a Notary Public, should be furnished on stamped paper duly sworn or affirmed by all the partners admitting execution of the partnership agreement or the general power of attorney. The attested copy of the certificate of registration of firm should also be enclosed along with the tender.
- 4.2 In the case of partnership firms, where no authority to refer disputes concerning the business of partnership firm has been conferred on any parties the tender and all other related documents must be signed by all partners of the firm.
- 4.3 A person signing the tender form or any documents forming part of the tender on behalf of another person should have an authority to bid such other person and if, on enquiry it appears that the persons so signing had no authority to do so, the University may, without prejudice cancel the contract and hold the signatory liable for all costs, consequences and damages under the civil and criminal legal remedies available.

5. Technical Bid:

- 5.1 The Technical bid should be submitted in forms given in Annexure- III along with Copy of PAN issued in favour of the firm or as applicable, Provident Fund number/ESI/service tax number/GST number etc. and any other information sought for in the last section of the Annexure-III.

6. Financial Bid:

- 6.1 The Financial Bid should be submitted **ONLINE** in the form given in Annexure IV. The Financial Bids of those tenderers who are found technically qualified, will be opened on a specified date and time to be intimated to the respective tenderer.
- 6.2 The rate to be quoted for Air conditioned and non-Air conditioned taxis on daily basis and monthly basis and for each kind of fuel i.e. diesel, petrol taxis separately. The rate quoted shall be inclusive of all taxes, GST/ toll tax, service tax & any other applicable Govt. duty/ etc.
- 6.3 Nothing extra beyond accepted rates will be paid by the University.
- 6.4 Terms of payment as stated in the Tender Documents shall be final.

7. Validity of the Bids:

The bids shall be valid for a period of 60 days from the date of opening of technical bid.

8. Opening of Tender:

The tenderer is at liberty either himself/herself or authorize, not more than one representative to be present at the opening of the tender. The representative attending the opening of the tender on behalf of the tenderer should bring with him a letter of authority from the tenderer and proof of identifications of both and will mark his attendance before opening of the tender.

9. Evaluation of Tender:

The evaluation of the tender documents will be made on the basis of technical information furnished in form given in Annexure-II & III. The financial bids of only those firms will be opened who will qualify the evaluation criteria. The rate contract shall be awarded to the firm who has overall quoted the lowest rate location wise tender. The reasons selection or rejection of a particular tender will not be disclosed. The award of work will be further subject to any specific terms and conditions of the contract given in Part-II of Annexure-II of this Tender document.

10. Right of Rejection:

10.1 The Registrar, I.K.Gujral Punjab Technical University, reserves all rights to amend/reject the routes specified in tender document. The Registrar also reserves all rights to reject tender not fulfilling the criteria mentioned in the tender document, without communicating any reason whatsoever and does not bind itself to accept the lowest or any specific tender. The decision of Registrar, I.K.Gujral Punjab Technical University shall be final and binding.

10.2 Any failure on the part of the contractor to observe the prescribed procedure and any attempt to canvass for the work will prejudice the contractor's quotation.

11. Award of Work:

The Registrar, I.K.Gujral Punjab Technical University will award the work to successful contractor at Lowest rates (L1) capacity of taxis as stated above.

12. Penalty:

(a) In case of breach of any condition of the contract and for all type of losses caused including excess cost due to hiring of taxi from the market in the event of Contractor failing to provide requisitioned taxis or not providing taxis in time, The Registrar, I.K.Gujral Punjab Technical University shall make deductions at **double the rate** of Hiring rate on prorated basis from the bills preferred by the Contractor or that may become due to the contractor under this or any other contract or from the security deposit or may be demanded from him to be paid within seven days to the credit of the I.K.Gujral Punjab Technical University.

(b) The powers of the Registrar, I.K.Gujral Punjab Technical University under this condition shall in no way affect or prejudice the powers in certain events to terminate the contract vested in him as herein provided nor forfeiture of deposit mentioned in the tender document.

(c) In case of breach of any of terms and conditions mentioned above, the Registrar, IKGPTU will have the right to cancel the work order (without any reason thereof) and nothing will be payable by the University in that case and the security deposit shall be forfeited.

13. Period of Agreement: Subject to other conditions appearing hereinafter, the contract shall be for a period of one (01) year extendable for three (03) years from the date of entering into contract based on the satisfactory performance. The contractor shall ensure that the service start operating from that date, when the supply order be issued.

Without prejudice to other provisions herein, the contract can be terminated by IKGPTU by giving a prior notice of one month (30 days) on violation of conditions of contract or on the grounds of

default in proper service. The contract can also be terminated by the contractor with a notice of one month to the IKGPTU on the grounds of failure of obligations on the part of the IKGPTU. For operation of this clause a Consultative committee on services of four representatives, one from contractor and three from IKGPTU which shall meet from time to time and submit their deliberations to the Registrar. The Registrar of IKGPTU or any other person authorized by the VC, IKGPTU will be Chairman of the Committee.

14. Subletting of Work:

The firm shall not assign or sublet the work or any part of it to any other person or party. **The tender is nontransferable.**

15. Payment Terms:

15.1 The contractor shall be paid on monthly basis or the basis of accepted rates. No payment shall be made in advance and no loan from any bank or financial institution shall be recommended on the basis of the order of award of work.

15.2 The contractor shall submit the monthly bills in the first week of month in respect of previous month (in case of monthly payments) for sanction of the amount of bill and passing the bill for payment.

15.3 All payments shall be made as per university's set provision as by Online transfer/RTGS/NEFT etc.

15.4 Registrar, IKGPTU shall be at liberty to withhold any of the payments in full or in part subject to recovery of penalties mentioned in preceding para.

15.5 The term "payment" mentioned in this para includes all types of payment due to the contractor arising on account of this contract excluding Earnest Money and Security Deposit governed by the separate clauses of the contract.

15.6 Wherever applicable all payments will be made as per schedule of payments stated in Part-II of Annexure-II.

16. Arbitration:

If any difference arises concerning this Tender, its interpretation on the payment to be made there under, the same shall be settled by mutual consultations and negotiations. If attempts for the conditions do not yield any results within a period of 30 days, either of the parties may make a request to other party for submission of the dispute for decision, by a sole arbitrator, to be appointed by the university. The provisions of arbitration and conciliation Act, 1996 and the rules framed there under and in force shall be applicable to such proceedings.

17. Jurisdiction:

The courts of Kapurthala, Punjab will have the exclusive jurisdiction to try the disputes.

Pre-Qualification Criteria

1. Experience of successfully providing supplying taxis to Central Govt./Pb.Govt./ Autonomous Body/Semi-Govt./Public Sector/ Reputed institutions etc. during last 04 years ending last day of month previous to the one in which applications are invited should be either of the following :
 - a) Three completed work costing not less than the amount 20 lakhs.
or
 - b) Two completed work costing not less than the amount 25 lakhs.
or
 - c) One completed work costing not less than the amount 40 lakhs

Enclose copies of satisfactory completion certificate issued by client of similar work as applicable above. In Contest to return/Amount earning CA Certificate is must.

2. The bidder should not have been blacklisted or debarred from bidding or declared as a non-performer by any Govt/semi Govt/ Autonomous body. There should not be any case pending with the police against the proprietor/Firm/Partner of the company.
3. The bidder shall submit an undertaking that they have not been blacklisted or debarred from bidding or declared as a non-performer by any Govt/Semi Govt/ Autonomous body and there is no police case pending against the proprietor/Firm/Partner of the company.
4. The bidder should have the following registration:-
 - i. Provident Fund Registration.
 - ii. ESI Registration(if applicable) as per Govt. provisions.
 - iii. GST.
 - iv. Valid PAN in the name of the bidder.

Enclose self attested copies of the above registration certificates.

5. If agency does not have valid license, PF registration, ESI registration, service tax registration and valid PAN, must give an undertaking that it will get the same in case the work is awarded to them.
6. The Tenderer should have valid Copy of PAN issued in favour of the firm or as applicable, Provident Fund number, ESI, GST /service tax number. The proof (self-attested) of the same is mandatory.

SPECIAL TERMS AND CONDITIONS

1. The taxis will generally be required by the University for Carrying Confidential Material from University Campus to its affiliated colleges and back to university and/or vice versa. The same may also be required for other types of journey such as inspections or order works of related to University etc.
2. IKGPTU will generally make the requisition for the taxis one to three hours before the commencement of the actual journey.
3. "Full Day" would imply a run of the Taxi up to 12 hours duration.
4. Meter reading will start/terminate from IKGPTU premises.
5. University may call vender to arrange taxi on monthly/per day on as per requirement in any station within the territory of Punjab & Chandigarh. This arrangement may charge only from the start city to destination city.
6. No mileage will be allowed for lunch/tea of the driver.
7. Driver should be in proper uniform, carry mobile phones, valid Driving License and other required documents/equipments specified by concerned Govt. departments. University will not pay any of fine/penalty imposed by any Govt dept. to the contactor/ Successful bidder.
8. Taxis to be provided by the Contractor should be in perfectly sound working condition and not more than 1 years old.(Evidence should be attached during the payment of bills).
9. The vehicles registered under Taxi categories should be provided.
10. Private vehicles shall not be accepted. Payment of such vehicles will not be made.
11. The Rates once finalized will be fixed for the total contract period including extensions (if any).
12. Upward change in rates will not be considered due to any hike in petrol/diesel/ prices or taxes during the period of contract
13. Rate contract can be extended upto 3 years on the same finalized terms and conditions at the discretion of the university.
14. Rates quoted shall be inclusive of all taxes, duties, diesel/petrol prices/toll taxes etc.
15. The successful contractor to ensure statutory compliance of direction/norms/conditions laid down by RTA/Traffic police/ESI/PF or other related bodies.
16. The contractor will implement all the Govt. notifications/orders & Acts issued by the State/Centre Government time to time.
17. The contractor will be responsible for any challan/penalty imposed for violation of any traffic rule or under the any Govt. or private body.
18. The contactor will responsible for any type of damage caused due to any reason (fires, accident, riots, strikes, lockouts, etc.).
