1. The intake capacity shall not be increased or varied without prior approval of the University;

- 2. No other course shall be started without prior approval of the University;
- Adequate funds shall be available with the Institution to meet the financial obligations of recurring and non-recurring nature as prescribed by the university, from time to time;
- The College shall create the necessary infrastructure as per the norms prescribed by the University for running the above courses during the session 2015-16.
- 5. All infrastructure, instructional and other facilities shall be provided as per the AICTE/University norms prescribed from time to time:
- Teaching and other staff shall be selected according to the procedure; qualifications, experience and pay scales as prescribed by the AICTE/University from time to time and the representative of the University shall be associated in the selections.
- The tuition and other fees shall be charged as prescribed by the State Govt./University within the overall criteria/limits as may be laid down by the University from time to time.
- 8. Admissions shall be made according to regulations /directions of the University;
- The Institutions shall not automatically become eligible to receive financial grant/assistance from the Central/State Govt. or any other funding agency;
- 10. The institution shall maintain the record and books of account in the proper form, as prescribed by the University;
- 11. The Accounts of the Institution shall be audited by Chartered Accountant or any competent authority and shall be open for inspection by the University or anybody authorized it;

- 12. The Institution shall be subject to special audit and inspection as prescribed by the University;
- 13. The institution shall furnish requisite returns as prescribed by the University for ensuring maintenance of standards;
- 14. The institution shall be visited by an Officer or a committee of the University to review the progress made by the institution in fulfilling conditions as laid down by the AICTE/University.
- 15. The Governing Body of the Institution shall be constituted, and its Chairman shall be appointed as per the guidelines of the University.
- 16. The Institution shall not charge any Capitation Fee or donation for admission or other higher charges from the students/guardians of the students in any form;
