In partial modification of Punjab Government Notification No. 13/105/2010-1TE2/314 dated 28.01.2011, the Governor of Punjab is pleased to amend the **Para (E) Sub Para (XVII & XVIII)** of General Condition may be read as under:-

In keeping with the direction of Ministry of Human Resource Development Department, Govt. of India all Institutions and Universities shall in public interest, maintain a waiting list of students/candidates. In the event of a student/candidate withdrawing before the starting of the course, the wait listed candidates should be given admissions against the vacant seat. The entire fees collected from the student, after a deduction of the processing fee of not more than Rs. 1000/- (Rupees One Thousand only) shall be refunded and returned by the Institution/ University to the student/candidate withdrawing from the programme. It would not be permissible for institutions and universities to retain the school/institution leaving certificates in original. Should a student leave after joining the course and if the seat consequently falling vacant gets filled by another candidate by the last date of admission, the institution must return the fees collected with proportionate deductions of monthly fee and proportionate hostel rent, where applicable.
