Dear Sir / Madam,

AICTE has issued a Public Notice for Online Approval Process 2017-18 which has been published in all leading Newspapers on 2nd January, 2017 (Copy available @ http://www.aicte-india.org/ApprovalProcess17_18.php) and same has been communicated through e mail to all the AICTE Approved Institutions and also displayed on AICTE website (www.aicte-india.org) along with necessary detailed information on procedural aspects including revised Approval Process Handbook 2017-18. The last date for all the AICTE approved Institutions to apply On-line for getting Extension of Approval (EOA) for the academic year 2017-18 is 04th Feb, 2017 (without penalty) and up to 9th Feb, 2017 (with penalty only for existing Institutions). As per the provisions of Approval Process 2017-18 (Approval Process Handbook 2017-18 available at http://www.aicte-india.org/ApprovalProcess17_18.php), the penalty is applicable for Government Institutions also in case of late submission.

AICTE has taken all the necessary steps in connection with Approval Process for the year 2017-18 to facilitate all the institutions to get Extension of Approval (EOA) in time for the year 2017-18. *In spite of all the efforts from AICTE some of the institutions coming under the purview of your University in the past have not submitted their applications in time for getting AICTE approval for the programs/Courses they are conducting/running.* In view of this, you are requested to intimate all the Institutions coming under the purview of your University to apply Online within the stipulated time to get approval for the year 2017-18.
