The Society since the year 1987-88 is engaged in giving financial Assistance in the form of Scholarship to the needy students getting vocational/Professional education on merit cum means and physical disability basis. The scholarship is awarded without any discrimination of caste creed religion or domicile. The criteria for eligibility are as under:

(A) ELIGIBILITY:

- i) The student should have passed the previous examination with a minimum of 60% marks.
