They will also be awarded with the "Certificate of Excellence" by AICTE. A faculty mentor/Supervisor has to be allotted (by the College/Institute) to these students for guiding, monitoring and evaluation of internship of these students.

The main aim of this initiative is to ensure hands-on exposure to graduating students on the industry trends and enhance their employability. It is also felt that internship experience with government organizations can be equally beneficial and enriching to the students especially in understanding the planning and implementation of various initiatives of state and central governments.

In this context, a letter has been sent to all District Magistrates in the country with a request to select five students from AICTE Approved Technical Institutions falling under their District to work as "AICTE Intern" under their guidance (Copy enclosed).
