Subject: **Putting Anovus Institute of Clinical Research in "No Admission Zone" from session 2017-18.**

Upon considering the below motioned facts the Academic Council of IKGPTU has decided to put Anovus Institute of Clinical Research in "No Admission Zone" from academic session 2017-18 onwards and the existing students shall continue till the completion of their course.

1. In session 2013-14 Anovus Institute was allowed to run from its transit campus situated outside territorial jurisdiction of IKGPTU i.e. at Chandigarh with the condition that Anovus Institute shall have to shift the campus within the jurisdiction of IKGPTU before the commencement of next academic year i.e. 2014-15. Further, upon request of Anovus Institute extensions were granted from time to time vide order no. PTU/DCD/1527 dated 08.07.2014, order no. IKGPTU/Reg/11393 dated 13.11.2015 and it was categorically conveyed in the last extension vide order no. IKGPTU/REG/2281 dated 12.08.2016, that no further extension shall be granted, since as per IKGPTU Act, University can affiliate collages/regional centres within the territory of Punjab except the districts in territorial jurisdiction of Maharaja Ranjit Singh Punjab Technical University, Bathinda.

2. It is further conveyed that to maintain quality standards in the technical education, Board of Governors of IKGPTU in its 64th Board meeting has also decided to close all the regional centres of IKGPTU and directed that no admission shall be made in these regional centres from academic session 2017-18. However, these regional centres shall run till the passing out of already admitted students.



3. To ensure the minimum standards for running an institute under IKGPTU, University has conducted the inspection of Anovus institute of Clinical research, Chandigarh by the expert committee including member of Board of Studies (Clinical Research) and Board of Studies (Medical Lab Science) in the presence of representatives of Anovus Institute. The observations of the committee are as under:

- a) The institute is having inadequate space for accommodating 180 students per year intake as per sanction order of PTU.
- b) Library facilities inadequate (Books).
- c) No seminar hall available.
- d) No Tutorial Room available.
- e) Library & computer lab in a same room.
- f) No bills of licensed software, computer, furniture etc made available to committee.

Therefore in view of above stated facts and decision of Academic Council of IKGPTU, Anovus Institute of Clinical Research is put in "No Admission Zone" from academic session 2017-18 onwards and the existing students shall continue till the completion of their course.
