Item No.1: Confirmation of proceedings of the last meeting of the Academic Council held on 6th July, 1999

The fifth meeting of the Academic Council was held on 6th July, 1999. The proceedings of this meeting were circulated vide letter No. 02.05.322-352 dated 22.07.99 (Annexure 1 pages 13 to 21). Some comments from SUS CET Tangori, AIET, Faridkot, GTB National Instt of Mgt & Technology, Dakha, BCET Gurdaspur. BBS Engg College, Fatehgarh Sahib and GNDEC Ludhiana were received which are being dealt with separately.

The matter is placed before the Academic Council for confirmation of the proceedings.

Item No.2: Computer course(s) for students not exposed to computers

A large number of graduates and students from different branches of engineering never get exposed to computers and remain computer illiterate. It is proposed to start one introductory and another advanced level course, both of 1 semester length each, to be offered to any student of PTU and to the graduates from outside universities for a fee. PTU affiliated colleges will offer these courses. This will bring needed revenues to the colleges / university, and will improve the employment prospects of the candidates.

The matter is placed before the Academic Council for consideration.

Item No.3: Using advanced machines available with the PTU and Polytechnic institutions

A number of Polytechnic and trade, schools (ITI) received sophisticated computer programmable machines with the help of World Bank loans. For example, ITI institutions at Rajpura, Hoshiarpur and Patiala got CNC milling machines with cam programming and simulation facilities, and those at Mohali, Ludhiana and Patiala have similarly equipped CNC turning machines. The PTU colleges must make arrangement with these institutions to make use of these and similar other machines for the training of engineering graduates. In fact, it is very important to coordinate resource-sharing even amongst the Engg. Colleges affiliated with PTU.

The matter is placed before the Academic Council for consideration.

Item No.4: Conduct of odd semester exams by colleges

It is proposed to experiment with the conduct of some semester examinations at the PTU affiliated institutions. To implement this proposal the first semester exam in year 2000 may be conducted by the teachers teaching the courses at the institutions. Depending upon the success of the experiment, the process may be extended to cover all the odd semester examinations. The council may also consider the discarding of supplementary examinations.

The matter is placed before the Academic Council for consideration.

Item No.5: Starting of M.E. programmes at Guru Nanak Dev Engg College, Ludhiana

Guru Nanak Dev Engineering College Ludhiana is offering Master of Engineering courses in:-

- 1. Production Engineering
- 2. Industrial Engineering
- 3. Electronics Engineering

The college had admitted extra students over and above the sanctioned strength in anticipation of attrition due to students leaving the courses mid session. The attrition did not happen and some students had to leave the courses because of this because the University did not permit admissions over and above the sanctioned strength. On the representations from two students, a one time exception was made to allow these students to continue studies. All institutions must admit students only upto their sanctioned strength.

The matter is placed before the Academic Council for consideration.

Item No.6: University Faculties

It is proposed that to begin with the University should have five faculties headed by Director of Senior Professor rank, assisted by Deputy Directors/Deans of Professor rank. The proposed faculties are:-

- 1 Engineering
- 2. Information Technology
- 3. Business Management
- 4 Basic Sciences and Humanities
- 5 Student affairs including training and placements

It is realised that recruitment to these posts will take some time and shall have to wait for the creation/acquisition of more permanent office and other infrastructional facilities at the University. In the interest of giving a fillip to the academic activities at the University, it is proposed to co-opt five professors from among the existing faculty to work as Deans on part time basis. The co-opted Deans will help the Vice-Chancellor on day to day academics matters while continuing working as Professors at their parent departments. University may pay a fixed honorarium to the co-opted Deans for their services. In the interest of smooth running of the University, it will be preferable that the co-opted Deans are working in Jalandhar or its close proximity.

The matter is placed before the Academic Council for consideration.

Item No.7: Replacement of Common Entrance Test (CET) by All India standardized tests

National Education System for Testing (NEST) organization, set up by the Government of India, is now ready to start all India tests to grade students for admission to various professional institutions in the country. These will be high level tests to measure the proficiency of the individual student and will be independent from the local variations in the education system. PTU may adopt the scores from these tests to replace common admission tests. The academic council may discuss the following points and take suitable decision.

- 1. Feasibility of adopting the NEST scores as the basis of admission to various colleges for the admission year 2001.
- Weightage allocation for the NEST scores, qualifying exam, i.e., 10+2 scores, and extra curricular activities, say 50%, 40% and 10%.
- Common admission for all institutions located in Punjab.

The matter is placed before the Academic Council for consideration.

No. 8: To allow 2 yrs certificate holders of SLIET to appear in CET

The Director, SLIET, Longowal vide letter No. SLIET/SET/44 dated 6.12.99 (Annexure II, page 22) has requested PTU to allow 2 yrs certificate holders of SLIET to appear in CET.

The students in certificate course are admitted after passing Matric on the basis of entrance test on all India basis. The duration of the course is 2 years and as mentioned in the request the students study basis sciences (Physics/Chemistry/Maths) of +2 level. For CET pass outs - the students studying in +2 (Physics/Chemistry/ Maths) are eligible.

It is pertinent to mention here that Panjab Univcersity, Chandigarh rexognized their certificate course for admission to B.A/B.Sc/BCA (Ist year) as intimated by the Institute through their above mentioned request.

The matter is placed before the Academic Council for consideration.

ITEM No.9: Criterion of attendance

The Principal, G N E Ludhiana vide his letter No. 2335 dated 17.8.99 has sent a proposal regarding criterion of attendance (Annexure III, pages 23-24) and requested that the matter may be discussed in the Academic Council. This issue needs thorough discussion.

The matter is placed before the Academic Council for consideration.

Item No.10: Introducing a course concerning communication in Punjabi

There is no course regarding "Communication Skills" in Punjabi being taught in any of the programmes of PTU. It is felt that knowledge of Punjabi is very much essential for the professionals who have to work in this part of the country. It is, therefore, proposed that either a slot may be created for introducing one or two courses concerning communication skills in Punjabi or the present course entitled "Communication Skills: may in corporate the above component.

The matter is placed before the Academic Council for consideration.

Item No.11: Revision of Academic Calendar for the year 1999-2000.

The examinations for the odd semesters are going to conclude on 14.01.2000 except in G.N.D.E.C, Ludhiana and S.B.S.C.E.T, Ferozepur where the date of last examination is 17.01.2000.

Due to late completion of exams, the Academic Calendar needs to be revised. The proposed revised Academic Calendar is placed at (Annexure IV page 25).

Counting of Equivalence subjects marks of 1998 batch students

The Principal, GZS CET Bathinda has requested for the counting of Equivalence subjects marks of 1996 batch students (Annexure V, page 26).

Three students named Mukesh Deepak, 2123/96, Harminder Pal Singh, 2326/96 and Harjit Kaur 2324/96 were admitted to the college in 1996. At that time, the college was affiliated to Pbi University, Patiala. These students appeared in the exams of 1st and 2nd semesters but could not clear the 50% papers and as per the scheme they were reversed to 1st semester and started their study alongwith 1997 batch and opted for PTU scheme of examinations. In the meantime, the college determined the equivalence of subjects offered by the Pbi University, Patiala and PTU Jalandhar. Copy of the order No. EAA/EQ/I dated 30.9.1997 is available at Annexure VI page 2. As per the equivalence, these students did not take exams in the papers already passed. The said equivalence was to be approved by the PTU so that the students could be given the credits for the exams passed under Pbi University, Patiala scheme. In order to settle the matter, the approval was granted by the Vice-Chancellor, PTU, vide Order No. 05.01.00.735-736 dated 15.10.99 (Annexure VII, page 28).

The meeting of the Academic Council was held on 11th June, 1999. It was adjourned to 6th July, 1999 because the agenda could not be completed. The adjourned meeting was held on 6th July, 1999. The following decisions were taken in these two meetings:-

Item No 1: Proceedings of 4th meeting of the Academic Council held on 5.10.99.

The Academic Council confirmed the proceedings of the Academic Council held on 5.10.98 making following amendments in Item No. 3:-

"The Academic Council approved the proposal to start B.Tech. course in Instrumentation & Control Engineering at GZS CET Bathinda with an intake of 40 students"

Item No. 2: Starting of Management Courses in Engineering Institutions Item No. 3: Starting of Integrated Courses of Engg & Management

The above two issues were discussed jointly. There were divergent views about starting of Integrated Course of Engineering & Management and also regarding Introduction of Management course in Engineering Institutions. It was decided that the matter may be given more thinking by the Institutions and they may send their views in writing. It may again be brought before the Academic Council for discussion in one of the next meetings.

Item No.4: Introduction of a paper on the History, Culture & Polity of India in Engineering & MBA/MCA Institutions

There was unanimity of opinion that a course on History, Culture & Polity of India in Engineering & MBA/MCA Institutions be introduced. However, the Chairman proposed that the members should give more thinking to the proposal and may suggest how it should be integrated and designed keeping in view the present course curriculum.

Item No.5: Rules & Regulations of Moderation of sessional awards

The following committee was constituted to propose regulations for moderation of sessional awards in Management courses:-

Item No.6: Re-evaluation of Answer Books

It was decided that re-evaluation fee may be enhanced to Rs. 500/- each paper. The Academic Council also recommended that in case there is variation of more than 15 percent between the 1st evaluation and the revised evaluation or the eter of the result changes to the advantage of the student as a result of reation, 75 percent of the fee may be refunded to the student.

No.7: Regarding Holidays in the Institutions affiliated to PTU

a minimum of 180 days teaching takes place in every institution. It was ided to recommend that the University may observe only the following days:-

Baisakhi Dewali 15th August 26th January 2nd October

addition to this, there may be two four restricted holidays which may be tided, by each institution as per the local needs. Each employee will be owed four restricted holidays which he/she may avail depending upon his/her noice and decision.

was decided to forward this proposal to the State Government for information ad approval. It was also decided that the University will take no note of any ther holidays declared by the State Govt./District Administration, except when there is a State level mourning or Statutory holiday like polling of votes etc.

Im No.8: Rules & Regulations for Ph.D degrees

The Academic Council approved the proposed regulations with the following modifications:-

Eligibility :

There will be no sub-headings in this clause.

2. Registration:

Clause 2.2 is to be replaced as under:-

"The application and synopsis shall be scrutinized by a research degree committee (RDC) which shall be constituted by the university for the relevant disciplines of Engineering/Technology science and Management and Computer application subjects separately.

Examination:

After the submission of the thesis by the candidate, the supervisor will submit a list of six experts (out of which three will be from abroad)...... The Vice-Chancellor shall approve two experts submitted through RDC of which one will be from abroad.

Herr No.9: Admission of J&K students

The Academic Council decided that the Principal, REC Jalandhar will take the decision at his own level.

ttem No.10: Shortage of Attendance

It was decided to have a detailed debate on various issues relating to academic reforms. The members of the Academic Council will send their suggestions within 15 days based on which the agenda item will be brought before the Academic . Council.

Item No.11: Relaxation of rules regarding promotion to 5th & 6th Semester for 1996 batch students of SLIET Longowal

The Academic Council ratified the decision taken by the Vice-Chancellor allowing promotion of students to the 5th & 6th semesters without passing first and second semester respectively in case of students of pertaining to1996 batch at SLIET Longoowal.

Item No.12: Permission to appear in External Examination of 6th semester.

The Academic Council agreed in principle to the proposal for allowing the students of GZS CET Bathinda and BBS Engg College, Fatehgarh Sahib to sit in 6th semester without clearing the 2nd semester so that their careers are not affected. However, it was decided that the approval may be conveyed only if Principal, GZS CET Bathinda recommends the proposal.

Item No.13: Bridge course being taught to Diploma students (admitted under LEET) in BBS Engg College., Fatehgarh Sahib and GZS CETBathinda

The Academic Council approved the proposal for dis-continuing the Bridge. Course for students admitted under LEET scheme. The decision shall be applicable to the students admitted in 1995 and thereafter. The Academic Council decided that nomenclature of the disciplines may be nended as under:-

Item No.17: Organization of Technology Camps in various Engg Colleges

Subject: TO ALLOW TWO YEARS CERTIFICATE HOLDERS OF SLIET TO APPEAR IN CET:

Sir,

Sant Longowal Institute of Engineering & Technology (SLIET) was established by the Govt. of India to provide Technical Education in emerging areas of Engineering & Technology . It caters to the technical manpower requirements at various levels by adopting a new concept of modular system in imparting Technical Education with emphasis on practical training in Industry. The announcement to set-up this Institute at Longowal was made by the then Finance Minister, Govt. of India in 1985 at the Bhog Ceremony of Late Sant Harchand Singh Longowal. The Institute was formally inaugurated by the then Minister of Human Resource Development, Govt. of India, on 20th December, 1991. The educational programmes of this Institute are non-conventional, innovative, practical oriented and contain all aspects of new education policy, 1986. It started certificate and diploma programs in various branches of Engineering & Technology in the year 1991 & the first batch of the students was admitted in October, 1991. The degree program has been introduced in the Academic year 1993-94. The programs started at SLIET have a built in flexibility to provide for innovation in the academic structure to enable and fulfill a wide variety of needs that currently exist and are likely to emerge in Punjab & other parts of the country. The programs in the Institute provide both lateral entry and vertical mobility at all levels of education, besides non-formal education & enterpreneurship development programs.

Propusal on the Criterion of attendance tourned

The criterion of attendance should not be diluted, instead, to impart quality Engineering Education, it should be enforced strictly because of the following reasons:-

In engineering courses equal emphasis is placed on Practical and Theory. Imparting skill to students through Laboratory training/experiments or Norkshops and Drawing class practice shall suffer irreparably, if students with lower than stipulated attendance are allowed to appear in the examinations

Moreover, in each subjact the Tutorial component shall cease to have a meaning, if attendance is made optional, ultimately harming the performance of the student in University and other job related examinations.

The importance of attendance is duly recognised in all professional courses like Medicine, Engineering and Management and it is mandatory to clear the Criterion of attendance in all leading engineering Institutions before a student is allowed to appear in an examination.

This also helps in better atmosphere in the Campus as far as/discipline and academics are concerned.

Regarding shortage of attendance, as per Hules, a student is supposed to attend atleast 75% of the scheduled lectures. The Frincipal can condone upto 10% lectures in a particular subject.

In case, the candidate/class is below the mark, then the student/class has to repeat the whole course in the next year and the same semester, when the subject shall again be offered.

If whole class falls short of the attendance in a specific course, then the course has to be offered for the whole of the class. In that case, the requirement will be to have additional teachers, additional classrooms for the whole/class, who were detained ducto shortage of attendance.

But, there is no provision as such for additional faculty to teach the whole/part of the class and the additional class rooms.

It is proposed that during the preparatory holidays classes may be engaged to make up for the shortage of attendance specially in practicals and extra assignments may be given in theory.

In case, a student/class is not able to make up for shortage of attendance in preparatories also, then the lectures shall be declared short and students/class will get reappear in that specific subject.

The class has two options in such a situation in a subsequent semester, when they can engage lectures in this subject, namely:-

- (i) student/class be aksed to attend lectures from denovo, as per rules, which seems guite difficult keeping in view the difficulties, as stated in paragraph-8 & 9, or alternatively.
- (ii) Class/students are asked ONLY to make up for shortage of the attendance, as declared in previous semester, or

(iii) any other alternative, suitable course of action, that this august Council may deem, most appropriate.
