Item No. 12.2 To consider the application of M/S IVRCL 1&P Ltd. for time extension

Granting time extension to M/S IVRCL up to 30/04/07 for the construction of Wing 'C' and upto 31/12/07 for the construction of wing A, B and core was approved subject to the following conditions

- (a) No direct or indirect escalation shall be allowed during the extended period and thus the rates of cement and steel shall stand frozen on 30/11/06 for Wing 'C' and on 31/07/07 for Wings A, B and Core.

- (i) Construction of 18 No type I Residences: The committee approved the construction of 18 no type I residences in the 2nd Phase.
- (ii) Construction of Guest House: It was decided to construct the Guest House as per original scope with Chancellor Suite at the ground floor with independent access. All the suites should have the facility of TV Connection, Internet connection, computer connection etc and all rooms should be of equal standard. The Architect shall also design the integrated furniture for the Guest House, Design may be revised accordingly.
- (iii) Convention Centre: The Committee decided that the sub-committee for resolving issues regarding Architecture and Technical Design for construction of PTU may discuss scope of convention centre at 12.30 hrs on 02/01/07. Sh. Chandra Mohan agreed to join the discussion.
