- Tendering, execution & supervision of works, Quality Control, billing etc, shall be done by PWD.

The matter is placed before the Standing Building Construction Committee for discussions and finalization of the scope of various agencies/departments involved.

Item No. 36.6: To discuss and review the scope of work of the Architect already engaged by PTU in light of the facts that the major construction works of the University are to be got done from Punjab PWD.

Punjab Government has accorded approval for waiver of Departmental charges of Punjab PWD for all the construction works of the University to be got executed through Punjab PWD. Under such circumstances, some of the activities which will be performed by Punjab PWD are already included in Architect's scope of works, as listed below:

- Preparation of detailed estimates and getting the same approve from PTU,

- ii) Preparation of detailed specifications.
- v) Analyzing and evaluation the bids
- vi) Check and approve design/shop drawings submitted by the Contractor/Vendor in terms of contract executed with them.
- vii) Render advice on the suitability of various samples of materials and components, if asked by PTU.
- viii) Certification of bills of the contractors.
- ix) Issue certificate of Virtual completion of works.

The matter is placed before the Standing Building Construction Committee for discussions and finalization of the scope of Punjab PWD and the Architect.

Item No. 36.7: To discuss and finalize the executing agency for construction of proposed new buildings for PITTTR at Ladowali Road, Jalandhar and Punjab Institute of Technology, Nandgarh, Bathinda.

During 35th meeting of the Building Construction Committee, it was decided that in case the departmental charges are waived off by PWD, the works of Punjab Institute of Technology, Kapurthala may be got executed from Punjab PWD on the terms and conditions agreed during the discussions held between the Building Committee and PWD officers (Agenda item No. 35.3). We have mentioned in the above referred table that B.Sc. Agriculture is a 3 year course, But actually it is a 4 year course. Since there are few practical classes in B.Sc(Agri), so even 3 classrooms will be sufficient. AS per AICTE norms, generally labs and classrooms for courses with intake of 60 students should have size of 66sqm.

There will be two departments:

- 1. Department of Management Studies
- 2. Department of Agriculture Science.

So It is proposed that

- Department of Management Studies should have 08 classrooms (66sqm. each), a computer Lab, deptt. office and rooms for faculty.
- Department of Agriculture Science should have 03 classrooms (66sqm each), 5 labs (66sqm. each), a computer Lab, deptt. office and rooms for faculty.

Apart from these facilities an administrative block and other general public facilities for students may be provided.

- Administrative block should have offices for Director, Registrar, Dy. Registrars (2No.). Establishment office, Accounts office, Store & Purchase office, Academics affairs office, Committee room/conference hall etc.
- General Facility includes building for library, offices for NCC & NSS etc., canteen, parking space etc.
