24.3 To brief about activities in the University.

Since the last meeting of the Board, the University has embarked on various activities. Some of the salient activities over the past couple of months include the following:

Academic Activities: During the current academic session, i.e. 2006-07, the University has affiliated 8 new colleges. These include one college of Engineering, One college of Pharmacy and 6 colleges of Management.

One Institution, approved by the AICTE in the last week of September, has so far not been affiliated since the approval letter was received by the AICTE after the last date of admissions fixed by the Government. Further decision with regard to this college, shall be taken only after the government issues the modified Notification.

New Courses: The University has started various new courses for the session 2006-07, after due approval of the Board of Studies and the Academic Council. These include:

B.Sc (Bio Technology), B.Sc (Hotel Management and Catering Technology), B.Sc(Media Entertainment and Film Technology)

M.Sc (Medical Lab Technology), M. Pharm (Pharmaceutical Chemistry), M.Pharm (Pharmacognosy), M.Pharm (Pharmaceutics).

Youth Festival:

Intra Zonal youth festival was organized from 7-11-2006 to 8-11-2006 in PTU affiliated institutes. Youth festivals were conducted in 4 zones simultaneously. In all more than 50 institutes participated in youth festival. The overall results for 4 zones were as under:

Distance Education:

Admission

Compared to the past five years PTU has enrolled maximum number of students in the last session. PTU DEP had during 2001-04 maintained student strength of around 15,000 where as the figure rose to 33,500 students in September 2005 and is expected to reach 70,000 students in September 2006. With the reforms, monitoring and introduction of newer techniques and methodologies PTU DEP is likely to grow at the same pace at least for the next 3 years.

Examination

The PTU DEP examination system has imbibed the latest reforms introduced within and outside the University system. Pre-printed attendance sheets were introduced and no complaint of question papers being out of syllabi was reported. A nodal center to assist the all India logistics of paper delivery and receipt was established at Delhi and the examination was conducted at 200 exam centers throughout the country without any major drawback.

Free Bus Pass

The University in close coordination with the Department of Technical Education could manage to provide free bus facility to its distance education students in PRTC buses plying inside and outside the state of Punjab. This facility has greatly benefited the poor students who travel large distances from their villages to carry on with their studies with the university in spite of severe resource crunch.

Scholarship Scheme for SC/ST students

The marginalized sections of the society viz. SC/ST students who wish to enroll now in the PTU DEP have been extended the scholarship facility by the government of Punjab under **Post Matric Scholarship scheme** sponsored by Government of India. This scholarship is available to all students enrolling under distance education program of the university belonging to SC/ST category and residents of the state of Punjab. The conditions of the scheme stipulates that students will have to pay their fees upfront and then the government shall reimburse their fee directly to the LC.

New LCs

As per the monitoring report of the Distance Education Council of PTU 110 learning centers that were not able to meet with PTU standards were closed. After nationwide advertisement the University received more than 800 applications from reputed institutes to establish learning centers in all parts of the country. After close scrutiny of applications and Expert Committee visits 300 learning centers were established for the session starting September 2006. These new Learning Centers are likely to add up in the growth and quality of learning imparted under distance education.

Brand Promotion

Extensive brand promotion was done across the country that has also increased the intake in the regular mode from other states. Extensive newspaper advertisement to the tune of Rs.2.00 crore was done by the RLFC's. Various events such as road shows, seminars and exhibitions were organized in various parts of the country to improve the brand image of PTU.

Scholarship for Physically Challenged Students

PTU announced scholarships for physically challenged students enrolled in its distance education program. The freeship is given as per the percentage of disability of the student as certified by a medical practitioner of the government of Punjab.

EDP Section

The University had established an EDP section especially for the distance education that has become functional and had assisted the University in fast and accurate result declaration process. This EDP section is being further strengthened to declare results in more efficient manner.

24.4 To brief on the progress of Construction work of PTU Campus at Kapurthala site.

The work of civil construction of administration building of the university was awarded in January 2006 with the time limit of 18 months and is progressing. Building consists of 4 stories front block and 8 stories rear block with the basement. Slab at the first floor of the front block is laid and the work of 2nd floor is in progress. Laying the slab at the ground floor level over basement in the rear block is in progress. Work of external service block, Air conditioning and electric work has been awarded recently. Work of the external public health has been put to tenders. Architectural designs of residential type 1 to 5, sports complex, guesthouse and the convention center have been approved and construction shall be undertaken in phases.

The person should be employed with a minimum of five of experience of 12000-18300 or equivalent in a educational institution. The person should be well versed with administrative and financial rules and general.

The post shall be at tenure post for a period of three years and person above the age of 57 (as on the last date of accept of the application) year shall not be considered. The post will be in the scale of 16400-22400. The selection committee may, at its discretion, allow a higher stating pay for person of exceptional merit.

- b) Till such time a new Registrar is appointed, Dr. V.K. Arora, Dean Academics may hold the office of the Registrar. He may assume the office of Registrar on expiry of the tenure of the present Registrar and will function as a Registrar till new Registrar assumes charge.

The present tenure of the Registrar expired on November 12, 2006 as decided the new Registrar to be appointed through advertisement at national level and selection by a duly constituted selection committee. Dr. V.K. Arora Dean Academics assumed the post of Registrar on 12-11-2006. He assumed the office of the Registrar till a new Registrar assumes charge.
