Item No. 33.6 To brief about the progress of PTU CAPARO School of Manufacturing & Material Technology.

A meeting of the Governing Body of PTU-CAPARO Society was held on 02.05.2009 in the Committee Room of Block 'A' of Punjab Bhawan, Copernicus Marg, New Delhi. The meeting was presided over by Lord Swraj Paul, Chairman of the Governing Body.

The agenda item containing the decision of the PTU's Board of Governors to bring into effect the decision of the PTU-CAPARO Society's Governing Body taken vide item No. 3 of its meeting held on 11-8-2008 regarding CAPARO's withdrawal from the PTU-CAPARO Society as per clause 5 of the MOU dated 3-7-2005 was considered. The information about the various steps to be adopted as recommended by the PTU's Committee constituted for effecting such withdrawal was given.

After discussions, the recommendations of the PTU Committee containing the steps as per clause 5 of the MOU for CAPARO's withdrawal from the PTU-CAPARO Society (placed at Annexure -A) were approved. Dr. R. S. Khandpur also mentioned that the value of the assets may be taken from the latest Balance Sheet of the Society. However, Lord Swaraj Paul emphasised that the Balance Sheet never represents the current value of the assets which must be considered for the purpose of their evaluation. He also mentioned that the withdrawal by CAPARO from the Society shall be subject to the evaluation of the assets of the Society which should also include the value of the 10 acres land which was to be transferred to the Society as per the MoU signed between PTU and CAPARO. The member representing PTU stated that this has to be decided by the Board of Governors of the PTU and its decision would be conveyed to the Society / CAPARO within the next 6 weeks for taking further action on the matter.

It was also decided that the liabilities of the Society, existing as well as those likely to arise, (the details of which lie with CAPARO) may also be worked out in the meantime so that they may be taken into consideration while evaluating the assets effecting the withdrawal by CAPARO under the clause 5 of MoU.

The matter is placed before the Board for consideration and further guidance.

Item No. 33.7 Brief about the CET - 2009 and Online Counselling.

a) CET - 2009

CET - 2009 was conducted on 3rd May 2009 in 90 centers located through out the state of Punjab. As many as 26375 candidates appeared for this test. The test was conducted smoothly. As per schedule of the CET - 2009 result of this test is scheduled to be declared on 26th May, 2009.

b) Online Counselling

In pursuance of the decision taken in 31st meeting of BOG held on 26.2.2009, the University shall be conducting Online Counselling for admission to B. Tech. / B. Pharmacy courses for which services of NIC has been taken. The counselling comprises of two rounds and shall be completed by 5th August, 2009.

The Counselling for the following courses shall however, be conducted manually:

1.	B.Arch. Counselling at PTU Campus, Kapurthala
2.	Counselling for Sports Category at PTU Campus, Kapurthala
3.	Sikh Minority General at GNDEC, Ludhiana
4.	Sikh Minority Reserve & 15% at GNDEC, Ludhiana
5.	Counselling by GNDU, Pbi. Univ., PAU for some reserved categories
6.	Counselling for 10+2 students
7	Counselling for LEET students at PTU Campus Kapurthala

Item No. 33.8 To approve the guidelines for giving Autonomy to PTU affiliated colleges.

The UGC has initiated a scheme of grant of autonomous to the colleges. The scheme is available to colleges offering not less than six programmes of which two maybe as the post graduate level. In so far as self-financing colleges are concerned, the scheme is applicable for those colleges which after opening have completed 10 years of existence. The autonomous college shall have the freedom of:

- Determine and prescribed its own courses of study and syllabi, and restructure and redesign the courses to suit local needs; and
- Prescribe rules for admission in consonance with the reservation policy of the state government;
- Evolve methods of assessment of students performance, the conduct of examinations and notification or results;
- Use modern tools of educational technology to achieve higher standards and greater creativity; and
- Promote healthy practices such as community service, extension activities, projects for the benefit of the society at large, neighbourhood programmes, etc.

Conferring autonomous status covers certificate, diploma, undergraduate, postgraduate and M.Phil. programmes offered in colleges that are autonomous and those seeking autonomous status. The parent university will confer the status of autonomy upon a college that is permanently affiliated, with the concurrence of the state government and the University Grants Commission. Before granting autonomy, the university will ensure that the management structure of the applicant college is adequately participatory and provides ample opportunities for academicians to make a creative contribution. An autonomous college has also got to themselves accredited by the NAAC within a period of two years from the date of conferment / extension of autonomous status.

A copy of the UGC scheme for grant of autonomous status is enclosed at Annexure V.

The matter is placed before the Board.

Item No. 33.9 UGC Guidelines to start off-shore campuses / learning centres abroad.

The UGC has made guidelines for universities / institutions for opening up off-shore campuses /learning centres abroad. As desired by BOG the UGC guidelines have been obtained (Annexure VI) and would be followed wherever applicable before starting of off-shore campuses / learning centres abroad.

The matter is placed before the Board for consideration.

Item No. 33.10 To consider Challenge Evaluation in Evaluation System

The Committee met on 16.3.2009 at 11:30 am and after detailed deliberations the committee has given the recommendations placed at Annexure-VII.

Recommendations have been approved in the 32nd Academic Council meeting. Summary of recommendations are given below:

It is recommended to amend the existing clause no. 7 of chapter XIV so that all the students will be provided the opportunity to apply for challenge evaluation by paying Rs. 2500/-. In case variation will be more than 25%, the fee will be reimbursed to the students and also suitable action shall be taken against concerned evaluator giving more transparency to the system. The minimum marks for re-evaluation have also been proposed to be fixed at 25% by amending Clause No. 1 of Chapter XIII, thereby reducing the number of re-evaluation applications.

Submitted for approval of BOG.

Item No. 33.11 Grant of increase and arrears to the fixed salaried employees of the University.

The Board of Governors in its 29th meeting held on 20.11.2008 vide item no. 29.6 constituted a committee for:

- a) Grant of increments to the fixed salaried employees of the University for the year 2003-04
- (b) Grant of corresponding pay scales to the fixed salaried employees

The committee has submitted its recommendations (placed at Annexure- VIII) for the annual increase in salary of the five employees for the years 2003, 2004 along with the corresponding increase in the subsequent increments and consequential arrears to these fixed salaried employees for the year 2003 to 2009 w.e.f 1.3.2003.

The matter is placed before the Board for approval,

Item No. 33.12 Special chance to M. Tech. Students for submission of final thesis who have cleared their all subjects.

The Academic Council in its 31st meeting constituted the following committee to consider grant of special chance to M. Tech. Students for submission of final thesis who have cleared all their subjects: -

- 1. Dr. M. S. Grewal, Principal, BBSBEC, Fatehgarh Sahib
- 2. Dr. M. S. Saini, Principal, GNDEC, Ludhiana
- Dr. N. P. Singh, Dean (Examinations), PTU, Jalandhar

The committee made the recommendations and are placed at Annexure-IX. Salient recommendations of the committee are reproduced as below: -

All cases where a student has cleared his / her theory paper and submitted thesis
after expiry of time limit, the thesis may be accepted as one time measures.

- In cases where a student has cleared theory subjects but has not submitted thesis, the student may be permitted to submit thesis with a nine months and the same may be evaluated within three months.
- 3. Provisions are one time measure and not to be taken as precedence.

These recommendations were approved in 32" Academic Council Meeting.

The matter is placed before the Board of Governors for approval.

Item No.33.13 Ratification of one time relaxation to M.Sc. IT course through Lateral entry.

Desh Bhagat Institute of Management & Computer Science, Mandi Gobindgarh is one of the affiliated institute of the University. One of the course being run by the institution is M.Sc. IT course. The college admitted 28 students who have passed their PGDCA into 3rd semester of M.Sc. IT during the month of July 2007 through lateral entry. A request was sent to the University to consider these students for issuing Detailed Marks Cards.

The matter was examined by the University and it was found that as per academic regulations the lateral entry in the regular courses is not permitted. Meanwhile the students approached the Hon'ble High Court for issuing of their Detailed Marks Cards.

The University through its Counsel informed the Hon'ble High Court that grievances of the petitioners (28) are under review of the University authority. Thereupon the Hon'ble High Court did not accept the petitioner's request to issue them DETAILED MARKS CARDS but had given the University 45 days from 16.02.2009 to decide the matter.

The matter was reconsidered by the University in the light of Hon'ble High Court judgment as well as in the interest of the large number of students who by this time had already cleared their examinations. Since the students have already appeared in the examinations and are now waiting for degree / DETAILED MARKS CARDSs for their placement / future prospects. We may consider allowing them as a special case. However, it should not be taken as a precedence and the college be asked to be extremely careful in making admissions strictly as per the academic regulations. The onus of responsibility of violation of regulations in future shall lie on the college exclusively. A penalty of fee of one semester be also imposed on the College for making these admissions.

Since the case has been approved by the Chairman, BOG. The matter is placed before the Board for ratification.

Item No. 33.14 To consider one time relaxation to the eligibility of M.Sc (IT) course CIIS-ST, Mohali

CIIS-IST is one of the affiliated Institutes of the University. One of course being run by the Institution is M.Sc.IT course. CIIS-IST admitted eight students in the course of M.Sc. IT during the Academic Session 2008-09. However, they have not studied Mathematic either at 10+2 or Graduation level. During the eligibility cheque-up these eight students have not been found eligible for admission to M.Sc. IT. Their admissions was cancelled.

These eight students have filed a writ petition no. 19626 of 2008 in the Hon'ble High Chandigarh (Amit Kumar and Others Vs PTU and Others) claiming that the University admitted the following three students during the session 2007-08 in M.Sc.IT without having passed Mathematics either at 10+2 or graduation level:

PTU had given statement in its written reply that the eligibility of above mentioned three students for admission to M.Sc.IT course is now under review by the respondent University authorities. The petitioners cannot equate their case with any previous admission, if made wrongly.

The Hon'ble High Court vide its order dated 06-01-09 passed the following order. An abstract is reproduced as under:

"So far as the relevance of the passing of mathematics subject at 10+2 level or graduation level for admission to M.Sc.IT course is concerned, I am of the considered opinion that mathematics subject is relevant for a students to seek admission to M.Sc. IT course.

In view of the facts and circumstances of the case given hereinabove, no ground for interference is made out. The impugned action is neither illegal nor irrational and does not call for judicial review. The impugned order annexure P-3 has been passed by a competent authority and is in conformity with the eligibility criteria. Petition dismissed".

Since the students have already appeared in the examination and are now waiting for their detail marks cards/Degree certificate, the case may be considered allowing them as a special case. However it should not be taken as a precedence and the Institute be asked to be extremely careful in making admissions strictly as per Academic Regulations. The onus of responsibility of violation of Regulations in future shall lie on the Institute exclusively.

Legal opinion has been sought in respect of the above. A copy of legal opinion is shown as **Annexure X**.

The item is placed before the BOG for approval.

Item No. 33.15 Conduct of examination for the dual BCA degree students under PTU at GB College in Toronto.

Chitkara School of Hospitality, Tehsil Rajpura, Distt. Patiala was allowed conduct of 5th semester examination in December 2008 for the dual BCA degree students under PTU and George Brown College in Toronto City (Cananda) as a one time measure and it has been decided that Chitkara School may get the examination conducted at George Brown College, Toronto (Canada) and arrange to send the answer books to the Punjab Technical University Jalandhar for evaluation in a sealed cover through a secured agency.

All the charges for the conduct of examination including sending of answer books etc. shall be borne by Chitkara School of Hospitality, Rajpura.

The matter is placed before the Board for information.

Item No. 33.16 To start six years integrated B.Tech. Programme

The percentage of rural students admission in professional colleges and universities in Punjab is less than 1% of the state population of the relevant age group. The only reason behind, is the non-availability of 10+2 non-medical students. The facts have also

been communicated by Shri K.S. Pannu, IAS, Member Secretary, The Punjab State Farmers Commission to the University mentioning that rural students cannot go to urban centres daily in the evening to take tuitions of Science and Mathematics (Annexure-XI). He also mentioned that majority of rural school don't have Science stream at +1 and +2 level as well as number of teachers for teaching Science, English and other important subjects are woefully less in rural schools. To boost the entry of the rural students, it is proposed that the University may start integrated professional courses on the similar pattern as that of PAU, Ludhiana and Punjabi University, Patiala at Talwandi Sabo (Yadavindra College of Engineering) and Rampura Phul (College of Engineering).
