# Item No. 40.3 Vice-Chancellor Report on University Activities.

#### 1. e-India Awards

The various PTU ICT initiatives and excellence in Distance learning have enabled the University to win two prestigious awards of the year 2010 in the "E-India 2010 Awards" at Hyderabad International Convention Centre, Hyderabad, on August 5, 2010. PTU has been honored with the awards for "Best ICT Enabled University of the Year" & "Best Distance Learning Initiative". This recognition will enhance the PTU BRAND Image which in turn will strengthen the employability of our students.

## 2. IBM's Centre of Excellence

IBM is going to establish 75 new Centers of Excellence (CoE) at engineering colleges across 60 cities in India.

In 2009 too, IBM set up over 75 such CoEs across the country and with the fresh announcement, the total number of CoEs around the country will be 150 by end-2010. These new CoEs will be spread across 20 states and will be selected from the top 300 engineering colleges in the country.

The IBM CoEs are aimed at creating a platform for the development of software skills among the students and also gives them the opportunity to acquire new skill sets around IBM software as well as help them develop top-class business solutions.

PTU has taken initiative in this regard and arranged a meeting with Mr. Mayank Jha, Relationship Manager/Academic Initiative, IBM India Pvt. Ltd on July 8, 2010. He addressed the HODs (CSE) of engineering colleges regarding the procedure & requirements of IBM.

Letter of Interest from 13 colleges have been received including 3 Government Colleges. The process will start in the month of August.

#### 3. Alumni Meet

Meeting of Coordinators of Alumni Association was held in PTU campus on July 20, 2010. Coordinators were informed to maintain the Alumni database year wise, batch wise & city



and other reputed Institutes/ Universities of the country to impart training and provide their valuable guidance in their respective fields. Even one expert is called from the University of Houston-Downtown, USA. These Faculty Development Programmes were arranged for all the streams like Engineering, Business Management, Hotel Management, Human Resource Management, Chemistry, Bio-Technology, Physics, Computer Science and other important aspects of technical teaching. So far, 80 FDPs had been organised in 23 Institutes and in another 20 programmes PTU faculty was sponsored to participate. In nutshell, about 100 such programmes were arranged by PTU for the faculty of its affiliated institutes.

# Item No. 40.4 Recruitment of 'C' & 'D' category posts

The positions for Clerks, Office Assistants, Attendants, Helpers were advertised in the month of December – 2009. However a CWP No 1304/2010 challenging the criteria of awarding extra weightage for continuous service in the university as per Item no 36.3 of the proceedings of 36<sup>th</sup> meeting of the Board of Governors held on 23/11/2009 ,was filed in Hon'ble High Court. In order to go ahead with the selection process, university sought legal opinion from standing counsel of University The opinion is re-produced as under:

"PTU shall put up the complete selection criteria approved by its BOG for filling up of C&D posts by open recruitment, on its official web site. Copy of the criteria is attached at Annexure- II

"PTU shall issue a public notice in the press that "The candidates shortlisted for various posts under the category C & D are hereby notified that the posts are advertised as per the terms and conditions approved by the Board of Governors. The selection and recruitment shall be subject to the final outcome of any order that may be passed in the various writ petitions (CWP NO. 15855 of 2009; CWP no. 20855 of 2009 and CWP No. 1304 of 2010) presently pending, or any other writ petition which may be filed in future, pertaining to the Punjab Technical University for the said advertisement dated 12.12.2009 in the Hon'ble High Court. Copy of the notice is attached at **Annexure** – **III** 



/Central Govt. Dept. or State /Central Govt. Institution, whereas for the post of Driver, it was 05 years.

University decided to amend the qualification and experience for the post of Driver. The amended qualifications and experience were as under:

### Qualifications:

- (a) Middle standard examination with Punjabi as a subject from recognized School / Board.
- (b) Must posses valid driving license to drive Light Motor Vehicles / Heavy Motor Vehicles.

**Experience:** An experience of driving light / Heavy vehicle for a minimum period of three years in a University or State /Central Govt. department or State /Central Govt. Institutions and have not been convicted of any offence indicating that he is not capable of performing the duties efficiently of the post of driver.

The same was placed on the official website of the University i.e. <a href="https://www.ptu.ac.in">www.ptu.ac.in</a> on 19.12.2009 and it was displayed to the public through website till the last date of submission of application i.e. 08.01.2010.

The matter was placed before the Human Resource Committee in its meeting dated 17.6.2010 and was proposed to be put up to BOG for approval.

# Item No. 40.5 Recruitment of 'A' and 'B' Category.

(i) 39<sup>th</sup> meeting of BOG sanctioned two posts of Deputy Registrars and four positions of Assistant Registrar instead of six posts of Assistant Registrars as recommended by HR committee. Against these positions, university initiated the process of appointing candidates from waiting list. In view of supreme court ruling related to appointment of waiting list candidates from newly created post, legal opinion is being obtained and the process for the time being is deferred. Annexure – IV

The matter is placed before the Board for information.

(ii) Representation from Shri Paramjit Singh who had applied for the post of assistant registrar was received by the university wherein Sh Paramjit singh has stated that since he belongs to Mazbi Sikh, he should have been given reservation as per the Punjab scheduled caste and backward classes act 2006,4(5) which is reproduced as below

" fifty percent of vacancies of the quota reserved for scheduled castes in direct recruitment shall be offered to Balmikis and Mazhbi Sikhs, if available, as a first preference from amongst the scheduled castes".

University sought legal opinion on the issue. The legal opinion obtained is reproduced as below:

"The Hon'ble Punjab and Haryana High court has declared above mentioned classification of the Punjab government further classifying the reservation 50-50 in scheduled caste category as unconstitutional and set aside the afore said amendment in section 4(5) of the Act,2006"

Shri Paramjit Singh in support of his case produced the recruitment results dated July 27, 2010 for Police Constable (Men) in the District Police Cadre wherein the Balmiki / Majbi Sikh has been given 50% reservation.

University, as an interim measure, has appointed Sh Paramjit Singh as Assistant Registrar on adhoc basis for a period of three months

The matter is placed before the Board for information and approval.

#### Item No. 40.6 Caparo Status

The Board in the last meeting decided that M/s Caparo should be communicated in clear terms that their Principle amount would be released only on signing of Memorandum of Settlement which must clearly state that there will be no further deliberations on past and future issues. The decision of BOG meeting was conveyed to M/S Caparo and accordingly after deliberations with them, Memorandum of Settlement has been drafted. The draft of Memorandum of Settlement was also circulated among the PTU nominees in PTU- Caparo



Society. The draft Memorandum of Settlement after incorporating the suggestions is appended at **Annexure – V** for consideration and approval of BOG.

## Item No. 40.7 Fee Enhancement

## a. Enhanced Fee Notification

In view of the revision of Tuition Fee for AICTE courses by the Punjab Government, the University has also revised the tuition fee for Non-AICTE courses on the same pattern. Notification has already been issued for the same and the tution fee with increase of about 10% is as follows:

# b. Revision of Development Fund & other student related fees

The Punjab Government has revised only the tuition fee for AICTE courses but development fund has not been revised. Keeping in view the huge expenses being incurred on the purchase of latest equipments, maintenance of building etc. and research works to be carried out. It is proposed to revise development fund & student related fees as per the following:

## Proportionate increase in affiliated related fee for Non-AICTE courses in view of the increase in Unit size of 40 to 60.

As approved by the 32<sup>nd</sup> meeting of the Academic Council duly approved by BOG, the unit size for Non-AICTE courses has been increased from 40 to 60. However no decision was taken regarding affiliation fee and other aspects of the same. Accordingly affiliation fee has been increased as per **Annexure-VI**

# Item No. 40.8 Project Competition at Pushpa Gujaral Science City

In order to promote creativity and innovation among the students of the professional colleges (Engineering Colleges and Polytechnics), it is proposed to organize an annual competition on projects / models. This competition will foster the spirit of innovative thinking and putting the ideas of the young students into practical applications.

As an experimental measure, this activity was organized in the Science City on the occasion of Technology Day (May 8, 2010). It was a great success. 44 models were displayed by different teams from various Engineering Colleges and Polytechnics. The prizes worth Rs. 35,000/- which were sponsored by PTU were awarded to the 5 best projects. Sh. Chander Mohan, Former Vice-Chairman, PTL and Member, BOG, PTU chaired the jury which selected the award winning models. The activity is now proposed to be organized jointly by Punjab Technical University and Pushpa Gujral Science City as an annual event.

The estimated expenditure for the yearly event is likely to be around Rs. 4 Lacs, which will be equally shared by PTU and PGSC. The PGSC would make all the arrangements for event management and inviting the participants through Press and other media and arrange for the



necessary infrastructure, whereas PTu will contribute the prize money for the winners of the Projects. The category and amount of prizes can be mutually decided PGSC and PTU.

The matter is placed before the Board for approval.

#### **ISTE Awards** Item No. 40.9

Punjab Technical University has decided to sponsor ISTE Awards for the innovative B.Tech Projects by students of Engineering Colleges affiliated to Punjab Technical University to stimulate the spirit of inventiveness among the technical students in order to honour and recognize with a mission to harness the creative talent for the benefit of Nation and Society.
