## Item No. 1 Confirmation of the Proceedings of 6<sup>th</sup> Meeting of Board of Governors held on 16.10.1999

The Board confirmed the proceedings of sixth meeting of the Board of Governors. (Annexure - I).

Item No. 2 Inauguration of City Centre Complex of Punjab Technical University at Ladowali Road, Jalandhar

The Board welcomed the inauguration of City Centre Complex of PTU by S. Jagdish Singh Garcha Hon'ble Minister for Technical Education at Ladowali Road on 19<sup>th</sup> December 2001. At this point the Chairman gave detailed background of the difficulties

hich had to be faced to reach the stage of the inauguration of this complex. The nembers of the Board appreciated the efforts made by the Chairman to make available ne building for the extended functioning of the PTU.

# em No. 3<sup>∨</sup> Review of the construction work of the Punjab Technical University campus at Kapurthala Road.

he Vice Chancellor gave detailed background of the steps initiated for the construction an of the university campus on the Kapurthala Road wherein it was expressed how I/S Sachdeva Eggleston Associates, New Delhi were engaged to prepare the master lan of the campus of the university. However, in the light of deliberations in the onstruction committee appointed by Govt. of Punjab, it was resolved to initiate the rocess again but make payment of the work done by M/S Sachdeva Eggleston ssociates, New Delhi. Subsequently at the instance of the Hon'ble TEM, the firm gave presentation before the Hon'ble Chief Minister at his residence, where Hon'ble TEM, hief Architect Punjab and his associates and the Vice Chancellor were also present. he Chief Minister was impressed with the presentation and ordered to go ahead with ne construction of the campus. He expressed that it should be on a fast track.

fter detailed discussions, the Board decided as under: 4

M/s Sachdeva Eggleston Associates, New Delhi be engaged as architects for the construction of the University campus on Kapurthala road. The rates and other terms & conditions may be settled with them after collecting the information from Guru Nanak Dev University, Amritsar whose construction plan was also prepared by them.

The following construction committee was constituted to conduct, monitor and supervise the construction work:

- 1. Vice Chancellor, Chairman
- 2. S. Atamjit singh Bawa, member Board of Governors.
- 3. Sh. R.S. Khandpur, member Board of Governors
- 4. Chief Architect, Punjab
- 5. Registrar
- 6. Engineer of the University, Member Secretary

The Board also noted that foundation stone of the Punjab Technical University campus at Kapurthala road was laid by His Excellency the Governor of Punjab on 20.12.2001 and Sardar Jagdish Singh Garcha Hon'ble Minister for Technical Education presided over the function.

### Item No.4 To approve the Distance Education Programme of the University

The Vice Chancellor explained the magnitude & seriousness of the problem of dropouts in the schools and colleges in the rural areas which is a matter of concern for the Chief Minister of Punjab and apprised the members that its only solution lies in a healthy and well organised Distance Education Programme. Punjab Technical University has played a leading role by initiating a number of programmes in this direction which have taken technical education to the door steps of students residing in innermost corners of the country particularly in rural areas.

The Director (Outreach), Mr. A. S. Grewal apprised the members that programmes o PTU are economical when compared to the exorbitant fee being charged by commercial organisations like Aptech and NIIT and further the inputs in the shape of study materials etc. by PTU match the international standards. The expertise and knowledge of Professors of IITs is made available to the students so that they are imparted state of art instructions. Mr. Grewal also explained to the members that the University was within its prerogatives to award degrees and diplomas and to devise syllabi and course curriculum for these programmes. This view point of the University has already been vindicated by the Supreme Court of India.

Sardar Atamjit Singh Bawa referred to a news item in the Ajit regarding PTU Distance Education programmes, particularly where Sh. Ramoowalia had commented upon the creditability of such courses. However, at the end of these discussions, he expressed that the positive aspects of the programme must be highlighted so as to develop a proper credibility of our functioning. oncluding deliberations, the Board approved the steps initiated under the Distance ducation Programme as detailed in the item alongwith the list of service providers with e following observations:-

Steps be taken to remove/clear the doubts in the mind of the students, their parents and public at large about the Distance Education Programme of the University and to counter negative propaganda so as to establish the credibility of the university.

Paid advertisements may be given in the news paper highlighting the University point of view, good points of the Distance Education Programme, the equivalence of the degrees and diplomas awarded by the PTU under this Programme with the degrees and diplomas of other universities.

Courses should conform to the overall structure of the degree system in the universities. The students passing out through the non-formal system should be able to join higher courses. If required, some bridge courses may also be introduced.

this point the Vice Chancellor brought to the notice of the members of the Board that on'ble Minister for Technical Education accompanied by Director (Outreach) took a pecial trip covering some of the states in South. During this trip they monitored the evelopment of study centres and interacted with service providers, controllers of chnical education, vice chancellors and other functionaries in Hyderabad, Chennai, ochin, Mumbai, etc. The trip undertaken by Hon'ble Minister in spite of his busy chedule in the interest of Distance Education Programme of the University is laudable. ne Board appreciated the gesture and felt grateful for this act.

### $_{ m em}$ No. 5 $^{ m V}$ To review the existing grade C & D staff and their placement.

ne Board considered the matter in details, and approved the following commendations of the Screening Committee constituted by the Vice Chancellor: -

- (a) The persons working against the posts of clerks, data entry operators, drivers, attendants, malis may be placed in regular scales.
- (b) All these employees be considered on probation for one year.

In addition to the above posts, persons, viz., JE, etc. who are in higher scale, may be considered for placement in respective scale after proper screening.

The Board further desired that statutory requirements regarding medical fitness and character verification of these employees may also be got completed within reasonable ime.

The Board also observed that the following action will be taken by the University:

Creation of additional posts may be brought before the Board of Governors at its regular meeting through the Finance Committee.

(ii) For further structuring of the staff, a hierarchical system be evolved, and senior positions be created and some of the present employees be given a chance to be placed in these positions on the basis of their experience, performance and capabilities.

Item No. 6 Ratification of Extension in term of appointment of Vice Chancellor

The board ratified the extension in the term of appointment of Dr. H. S. Gurm as Vice Chancellor for a period of one year w.e.f. 12.07.2000.

Dr. H.S. Gurm did not participate in this decision.

The following items were placed before the Board with the permission of the chair.

Item No. 7 To determine the amount of remuneration and other conditions of service of the Vice Chancellor, PTU, Jalandhar.

It was brought to the notice of the Board that Vice Chancellors in all the Universities in the state are being allowed to draw pension, if any, in addition to the prescribed emoluments. The Board accordingly decided to recommend to the Chancellor that Prof. H. S. Gurm may also be allowed to draw pension in addition to his salary. The Board desired that these recommendations, supported by documentary evidence, be forwarded to the Chancellor for approval.

Dr. H. S. Gurm did not participate in this decision.

#### Item No. 8 To start Teaching and Research Activities in the PTU.

The Vice Chancellor brought to the notice of the members that although the university is now five years old, it has no teaching department so far. Although some of the colleges affiliated to the PTU are doing very well, but there is shortage of well trained and *qualified staff to cope with the new technologies.* In order to over come the short coming and to establish centres of excellence, which will attract higher grade manpower and would be able to generate a synergy, the University needs to start teaching and research departments at its campus.

After considering the matter in detail, it was decided by the Board that University should proceed to take steps to implement such programmes for which the details be worked out, for their approval & implementation.

The meeting ended with a vote of thanks to the chair.
