Board was of the considered view that it would be in the interest of both PTU and Caparo, if criminal and other litigations launched by M/s G.S. Builders, M/s Rajindra Furnishers & others against PTU-Caparo Society and its members individually, related to delays in payment of their outstanding dues, and other litigants / suppliers with similar outstandings, were to be settled on priority.

The Board accordingly authorised PTU management to negotiate with the said litigants if they are agreeable to reach a compromise with the Society for withdrawing all their said pending criminal / civil cases in any Court on payment of their alleged dues which may be ascertained from them and agreed to. If the said litigants so agree, then the PTU will pay their said agreed amounts from its own funds on behalf of the PTU-Caparo Society upon their giving an undertaking of withdrawing the said criminal / civil cases in all the concerned courts. This payment of the dues of the said litigants will be subject to the condition that the PTU-Caparo Society accepts the said amounts as a liability on the Society by way of interest free loan advanced to it by the PTU.
