


39.07 Academic autonomy for GZSCET, Campus

For the above purpose autonomous Institution status is required for the Campus. 39.27. Student free ship scheme

Punjab Technical University (PTU) is seriously thinking about the students of weaker section of society. PTU has taken a step in this direction and Rs. 2.5 Crore sanctioned for the students of weaker section of Society.

The students belonging to following categories can apply for PTU-Free Ship Scheme for financial assistance:

- (i) **Parent less students:** eligible for financial assistance for full free ship of fee, if the total family income of the student is less than 2.50 lakh from all sources.
- (ii) Father less students: eligible for financial assistance for half free ship, if the total family income of the student is less than 2.50 lakh from all sources. In case the income of concerned is less than 1.20 lakh then he/she shall be eligible for financial assistance for full free ship.
- (iii) **Low Income Group students:** eligible for financial assistance for half free ship, if the total family income is less than 2.50 lakh from all sources. In case the total family income is less than 1.20 lakh then he/she shall be eligible for financial assistance for full free ship.

in an endeavour to provide the e journals at discounted prices to all its affiliated colleges, the University has able to get discount on subscription of these journals.

The university itself offered 10% discount as a grant to all the affiliated colleges so that more no of colleges may join it and would be able to provide the better research facilities to its students and faculty. The subscription cost of these journals through DELNET was Rs 52,500 + 7,500 (Delnet Subscription charges) i.e. total subscription cost was Rs 60,000 for per Engg package. Whereas by joining the PTU consortium the colleges have got this package in just Rs 39,375. i.e. in actual at 35 % discount in total. It is worthy to mention here that none of the colleges throughout the India has able to get that much discount on any of these e journals. Appreciating the sincere and candid dealings of the university authorities the publisher has offered PTU the reimbursement of the 15 % discount amount to those PTU colleges who somehow missed to join the PTU consortium but has subscribed these e journals through DELNET. Those who wish to avail this reimbursement may send their application to the Dean (Academics). The details are placed at Annexure – XIV.







Fig. 1: Structure for Non-medical and Vocational Stream after Matric

The courses to be started at Punjab Institute of Technology (PIT), Mansa, will provide flexible, modular approach, so that the student once admitted will be allowed to leave on completion of any module and also will be able to make entry to higher module after a period of time. Further keeping in view the service to the Rural Poor the 50% seats will be reserved for the Rural Students and five seats in Non-Medical discipline will be reserved for the students from within the revenue limits of Mansa Kalan (including Mansa City), in view of the land donation, as per the Punjab Government policy. Further distribution of these five seats will be as per the flow chart in Fig. 1

Initially the classes will be started at transit campus at Mansa from session 2011-12, if so p. After the completion of building the the students shall be shifted to the main campus, PIT, Mansa.

Admission, for 270 seats, is made in 10+1, on the basis of merit of matriculation, in the following four streams:

On completion of 10+1, the successful students are upgraded to 10+2, in respective streams. The failed students at any level will be allowed to complete the course with the immediate junior batch and for such cases the extra seats according to the number of students can be generated. For such students only one chance will be given to complete the studies with the immediate junior batch, failing which they may be declared as unfit for that course. No direct admission will be made at 10+2 level in any of the stream.

After completion of 10+2, the students of Non-Medical and Vocational Stream can take admission to the higher module i.e. **Bachelor of Technology (B.Tech.)** in any of the following five disciplines:

- 1. Electronics & Communication Engineering (ECE)
- 2. Electrical Engineering (EE)
- 3. Computer Science & Engineering (CSE)
- 4. Mechanical Engineering (ME)
- 5. Civil Engineering (CE)

The promotion will be made in the discipline of choice of individual on the basis of the merit in 10+2 examination strictly as per the Reservation of seats indicated in Table 1 and also shown in Flow Diagram (Fig.1). Any seat remains vacant will be filled by the direct admission.

Annexure - IV

The successful students of 10+2 Medical Stream can make entry to higher module, i.e. Bachelor of Science (B.Sc.) (Medical) and then in Masters of Science (M.Sc.), as shown in Fig.2. Any seat remains vacant will be filled by the direct admission.

The successful students of 10+2 Commerce Stream can make entry to higher module, i.e. B.Com. Professional and then in Masters of Business Administration (MBA), as shown in Fig.3. Any seat remains vacant will be filled by the direct admission.

This modular approach, with vertical mobility, having multi-entry and multi-exit feature at different levels developed. The students can be allowed to change the discipline at 10+1 and 10+2 level by passing bridge courses designed to provide flexible approach for the promotion of students to higher courses. The students will have the option to leave the course after successful completion of each module and will have the option to join back in higher module after acquiring industrial/job experience. Such candidate will have the preference on directly admitted students. Modular flow of courses is depicted in Fig.1.

- 1. The reservation will be as indicated in Table 1 i.e. for Rural and General Students, where as each category will have further reservation as per PTU/ Punjab Govt. **Reservation Policy.**
- 2. Admission to 10+1 courses will be made on the basis of matriculation merit or entrance examination.
- 3. Lateral entry for Diploma (Engg.) / B.Sc. Degree holders into 2nd year of 4 year B.Tech. will be provided as per Punjab Government norms.
- Reservation for the students from within the revenue limits of Mansa Kalan 4. (including Mansa City) is as per the Table 1.
- 5. The direct admission will be made in the first year of B. Tech courses with 30 additional seat to each as well as to the vacant seats from the general category students with reservation as per PTU/Punjab Govt. policy. The preference for direct admission will be given to the internal students those wants to change the discipline after passing bridge courses. The direct admission to B.Tech. 1st year will be made on the basis of merit of IIT/JEE Exam.

VARIOUS COURSES & ELIGIBILITY

10+1 Non-medical / Medical / Commerce **Eligibility Criterion:**

- 1. The student should have passed matriculation examination with minimum 55% marks (50% marks for SC/ST category).
- 2. The students who fail in any one of the subject English, Science and Mathematics are not eligible for admission.

B. Tech. Course (4 Years Course)

Eligibility Criterion:

- 1. The student should have passed 10+2 (Non-medical) with minimum marks as per AICTE norms.
- 2. The students, who fail in any one of the subjects Physics, Chemistry or Maths are not eligible for admission.

B.Sc. Medical

Eligibility Criterion:

1. The student should have passed 10+2 Medical with minimum 55% marks (50% marks for Sc.ST category).

Lateral entry for diploma holders/B.Sc. Degree Holders into 2nd year of 4 year B.Tech. Course against vacant seats and additional 15% seats of the sanctioned intake in each branch of engineering.

Eligibility Criterion: All those candidates who have passed the diploma in any branch of Engineering and Technology from recognized institution of Punjab or from other state of India with minimum 60% marks in aggregate (for SC/ST 55%) or equivalent grade point, or Degree in science (B.Sc. with mathematics as one of the subjects) from recognized institution with 60% marks in aggregate or equivalent grade point are eligible for admission for above mentioned B. Tech. Courses. Admission will be made on the basis of merit in the qualifying examination and candidate's preference to different branches of engineering. Preference will first be given to diploma holders and the seats remaining vacant will be offered to the B.Sc. Degree holders. A candidate with diploma in any branch of engineering & technology can opt for any of the available branches of B.Tech. Course.

Loan for Students

Students who take admission under Economically Weaker Rurai Area category will be eligible for interest free loan

Deserving students will be given an interest free loan to cover their tuition fee and other charges (excluding mess and hostel charges). This loan will be repayable after the student passes out and is engaged in employment. The students who drop out or do not pass the course will have to repay the loan immediately. The student/parents will have undergone agreement on an affidavit in this regard. Initially the amount will be given by the University and the efforts will be made to create a common money pull through donations and from government policies for such type of loans. Such students will only pay the tuition fee and no University fund will be charged except the examination fee.

Note: Rules for the grant of the loan will be as formulated by the PIT from time to time.

NAMES OF STREET, STREE

Conditions for admission to Economically Weaker Rural Area category, to integrated course after matriculation:

- Student should have passed/ appeared in their matriculation examination held by a recognized board/ council with minimum 55% marks for General and OBC Categories and 50% marks for SC/ST category. Students, who are fail in any of the subjects of English, Science and Mathematics in matriculation examination, will not be eligible for admission.
- Admission under this scheme will be considered on the basis of average marks obtained in the subjects of English, Science and Mathematics in matriculation examination or on the basis of entrance examination.
- 3. The student should have passed his 5th class from a school situated in a village, which does not fall within the limits of a municipal committee or corporation or under a small town/ notified area.
- 4. The student should have passed his matriculation and previous four classes of study (i.e. from 6th to 10th) from a recognized/Affiliated school in a village which does not fall within the limits of a municipal committee or corporation or under a small town/ notified area.
- 5. The annual fee and other charges of the school (s) from where the student has passed his matriculation and all lower classes should not exceed the minimum tuition fee charged in any of the Govt. School of Punjab.
- 6. The student and his/her parents must be permanent residents of a village which does not fall within the limits of a municipal committee or corporation or under a small town/ notified area.
- 7. The combined annual family income of the student (parents & grandparents, if living together) should not exceed Rs. 2,50,000/- per annum.
- 8. The admission at any level of Integrated course will be provisional subject to physical verification of above conditions. The admission of students, in case of negative verification, will be cancelled and they will have to deposit full fees till that time.
- 9. Interest free loan is provided to the students under this scheme on the basis of a legal agreement by the student/parent on an affidavit. This loan will be repayable after the student passes out and is engaged in employment. The students who drop out or do not pass the course will have to repay the loan immediately.
- If any student leave the studies/course in between then he/she will have to pay the entire fees till that time.
- 11. If any student gets detained due to short of lectures in any subject then from next semester onwards he/she will not be eligible for interest free loan.
- 12. If a student indulges himself/herself in any of the indiscipline activity, the interest free loan facility will be withdrawn immediately.

FEE STRUCTURE

The fee structure of 10+1 and 10+2 courses will be at par with the fee structure of Govt. Polytechnics, without any other fund except examination fee. The fee structure of graduation level courses will be at par with the fee structure of Govt. Engineering Colleges, without any other fund except examination fee. However the University will not charge any fund except tuition fee from the students admitted under Economically Weaker Rural Area Category.



The Guru Kashi University (GKU) represented by its Vice-Chancellor, having its office at Talwandi Sabo, Distt. Bathinda, Punjab in India hereinafter referred to as the FIRST PARTY

AND

The Punjab Technical University (PTU), represented by its Vice-Chancellor, having its office at Kapurthala (Punjab) in India hereinafter referred to as the SECOND PARTY.

WITNESSETH that

GURU KASHI UNIVERSITY, TALWANDI SABO

WHEREAS, the First Party is an Educational Institution of National importance engaged in advancement of teaching, research and extension activities in various fields of science, technology and education.

WHEREAS, the Second Party is an Educational Institution of National importance engaged in advancement of teaching, research and extension activities in various fields of professional education.

WHEREAS both, the First Party and the Second Party have come to an understanding to promote Teaching, Research and Education

NOW, THEREFORE, IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. STATEMENT OF PURPOSE INCLUDING OBJECTIVES

To have collaborative academic, research and faculty development programme in the area of Management, Education, Engineering, Science and Technology.

2. TERMS AND CONDITIONS

(These are general guidelines and may need to be modified on case to case basis)

- This MoU is valid for a period of Five years at the first instance, but can be extended with the consent of both the parties.
- This MoU shall be deemed to have been automatically rescinded after the expiry of the (ii) MoU period, unless renewed for any further period as per mutually agreed upon terms at a later stage

- (iii) Either of the parties hereto shall been entitled to terminate the MoU at any time with valid reasons, acceptable in writing to both parties and in such case, the MoU will terminate six months after the date of written notification or on the date of expiry of the MoU, whichever is earlier. In case of such premature termination of the MoU, all rights and obligations of both parties shall automatically cease, except for those covered by written contracts including ongoing collaborative activity that can no longer be cancelled.
- (iv) In case of any dispute that may crop up during execution of MoU, the matter would be settled through arbitration by referring to Arbitration Committee comprising of three members. Two members, nominated one by each party and third member will be jointly nominated by the two parties.
- (v) Faculty of both the Universities and that of its affiliated / constituent colleges will be considered at par for the purpose of attending / organizing faculty development programme.
- (vi) One party can extend its facilities for the other party to organize Faculty Development Programme for the faculty of either / both parties.
- (vii) Faculty of both the Universities and that of its affiliated / constituent colleges will be considered at par for the purpose of research guidance.
- (viii) The available research facilities of both the Universities and that of its affiliated / constituent colleges will be open for the research scholars registered with either of the Universities. To utilize these facilities the research scholars will be considered at par with the research scholars of either of the University.
- (ix) Both the Universities can collaborate on research projects and joint proposals may be submitted to the funding agencies.
- (x) Research scholars can fulfill the residency requirements from either of the University.
- (xi) All credits and benefits for collaborative work including the intellectual property (IP) generated during the tenancy of project would be equally shared between both parties i.e. both parties shall be the joint owners of this IP.
- (xii) The collaborative programme between two parties shall be coordinated by a Coordination Committee consisting of one member from each party.
- (xiii) The decision regarding patenting of the technology developed shall be taken jointly by the Co-ordination Committee. In case the technology developed is to be patented, the cost of patent and benefits accrued shall be shared as per the consent of both the parties. Rights pertaining to third party, if any will be decided jointly by the first two parties. Rights for commercialization shall rest jointly with both the parties and shall be decided by the coordination committee. In case of involvement of private sector, decision will be taken through joint consultation and keeping in view the consent of both the parties.

- 1. Centres of IITTM are located at Delhi (north), Goa (West), Bhubaneswar (East) and Nellore (South). IITTM from its different centres offers two year Post Graduate Diplomas in Management. These programmes are all approved by All India Council for Technical Education (AICTE). Besides these programmes, IITTM is also exclusively responsible for training the highest level of tour guides (Regional Level Guides) who are licensed by Central Government. IITTM is fast becoming the think tank for the government. It conducts researches to provide necessary inputs for policy making and evaluation. IITTM is also approached by various public and private parties for consultancies including specialist training, feasibility reports preparation etc. IITTM also carries out extension programmes. IITTM is also the nodal agency for Central Government's ambitious Capacity Building for Services Providers (CBSP) scheme.

This Memorandum of Understanding (MOU) is entered into on this _____ day of July, 2011 between

The Punjab technical University (PTU) represented by its Vice Chancellor, Having its office at Kapurthala (Punjab) in India hereinafter referred to as the *PARTY OF THE FIRST PART* and The Indian Institute of Tourism and Travel Management (IITTM) represented by its Director, having its office at Govindpuri, Gwalior (M.P.) in India hereinafter referred to as the *PARTY OF THE SECOND PART*.

WITNESS that

WHEREAS, the Party of the First part is an Educational Institution engaged in advancement of teaching, research and extension activities in various fields of technical education; and

WHEREAS, the Party of the Second Part is an Educational Institution of National importance engaged in advancement of teaching, research and extension activities in various fields of tourism and allied sectors.

WHEREAS both, the party of the First Part and the party of the Second Part have come to an understanding to promote Teaching, Research and Education

NOW, THEREFORE, IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. STATEMENT OF PURPOSE INCLUDING OBJECTIVES

To have collaborative academic and research programme in the area of tourism and allied sectors.

- 2. TERMS AND CONDITIONS (These are general guidelines and may need to be modified on case to case basis).
 - (i) This MoU is valid for a period of **five years** at the first instance, but can be extended with the consent of both the parties.
 - (ii) This MoU shall be deemed to have been automatically rescinded after the expiry of the MoU period, unless renewed for any further period as per mutually agreed upon terms at a later stage.
 - (iii) Either of the parties hereto shall be entitled to terminate the MoU at any time with valid reasons, acceptable in writing to both parties and in such case, the MoU will terminate six months after the date of written notification or on the date of expiry of the MoU whichever is earlier. In case of such premature termination of the MoU, all rights and obligations of both parties shall automatically crease, except for those covered by written contracts including ongoing collaborative activity that can no longer be cancelled.
 - (iv) In case of any dispute that may crop up during execution of MoU, the matter would be settled through arbitration by referring to Arbitration Committee of a member nominated each by two parties and one member will be jointly nominated by two parties.
 - (v) Faculty of both the Universities will be considered at par for the purpose of research guidance.
 - (vi) Faculty of Indian Institute of Tourism and Travel Management would be able to register scholars who have successfully completed AICTE approved 2 years PGDM/PGDBM (where the duration of the course is at par university MBA) programmes from any of IITTM centers. Faculty would also be allowed to register candidates for the programme at it different centers.
 - (vii)Scholars so completing the requirements of the research programme shall be awarded PhD degree by Punjab Technical University, Kapurthalla.
 - (viii) The available research facilities of both of the institutions will be open for the research scholars registered at either of the institutions. To utilize these facilities the research scholars will be considered at par with research scholars of either of the institution.
 - (ix) Research scholars will fulfill the coursework and residency requirements from the respective institutions.

- (x) Both the Institutions can collaborate on research projects and joint proposals may be submitted to the funding agencies.
- (xi) All credits and benefits for collaborative work including the intellectual property (IP) generated during the tenancy of project would be equally shared between both parties i.e. both parties shall be the joint owners of this IP.
- (xii) The collaborative programme between two parties shall be coordinated by a Coordination Committee consisting of one member from each organization.

INTERNAL QUALITY ASSURANCE CELL (IQAC)

Punjab Technical University Jalandhar

Introduction:

The University Grants Commission (UGC), established in November 1956 as a statutory body of the Government of India through an Act of Parliament, has the unique distinction of being the only grant-giving agency in the country which has been vested with two responsibilities: that of providing funds and that of coordination, determination and maintenance of standards in institutions of higher education.

The UGC's mandate includes Promoting and coordinating university education; Determining and maintaining standards of teaching, examination and research in Universities; Framing regulations on minimum standards of education; Monitoring developments in the field of collegiate and university education; Disbursing grants to the Universities and Colleges; Serving as a vital link between the Union and State Governments and institutions of higher learning; Advising the Central and State Governments on the measures necessary for improvement of university education. To monitor standards of the higher educational institutions it has established the National Assessment and Accreditation Council (NAAC) as an autonomous body, under section 12 (ccc) of its Act in September 1994. NAAC is entrusted with the task of performance evaluation, assessment and accreditation of Universities and Colleges in the Country. The philosophy of NAAC is ameliorative and enabling rather than punitive or judgmental, so that all constituencies of institutions of higher learning are empowered to maximize their resources, opportunities and capabilities.

NAAC has been instilling a momentum of quality consciousness amongst Higher Educational Institutions (HEIs or 'Institutions'), aiming for continuous improvement. NAAC is triggering a 'Quality Culture' among the various constituents of the HEI, as well as enhancing the awareness of institutional Quality Assurance with all stakeholders. At this instance Punjab Technical University has proposed to establish the Internal Quality assurance Cell (IQAC) as a pre accreditation quality sustenance activity.

The IQAC is meant for planning, guiding and monitoring Quality Assurance (QA) and Quality Enhancement (QE) activities of the HEIs. The IQAC may channelise and systematize the efforts and measures of an institution towards academic excellence.

Goals

a. To develop a quality system for conscious, consistent and catalytic programmed action to improve the academic and administrative performance of the HEIs;

b. To promote measures for institutional functioning towards quality enhancement through internalization of quality culture and institutionalization of best practices.

- c. The documentation and record-keeping Cell for the institution including assistance in the development of the API criteria based Performance Based Appraisal System (PBAS) performa using the indicative template separately developed by UGC.
- d. The IQAC may also introduce, wherever feasible, the student feedback system as per the NAAC guidelines on institutional parameters without incorporating the component of student's assessment of individual teachers in the PBAS.
- e. Document and collate annually the performance of Teachers for follow up by the University /college authorities. To prepare and publicize within six months subject-wise lists of journals, periodicals and publishers under categories III A and B of PBAS.
- f. Implementation of CAS Promotion for teachers.

The IGAC shall have the following functions

- a. Development and application of quality benchmarks/parameters for the various academic and administrative activities of the HEI;
- b. Facilitating the creation of a learner-centric environment conducive for quality education and faculty maturation to adopt the required knowledge and technology for participatory teaching and learning process;
- c. Arrangement for feedback responses from students, parents and other stakeholders on quality-related institutional processes;
- d. Dissemination of information on the various quality parameters of higher education;
- e. Organization of inter and intra institutional workshops, seminars on quality related themes and promotion of quality circles;
- f. Documentation of the various programmes/activities of the HEI, leading to quality improvement;
- g. Acting as a nodal agency of the HEI for coordinating quality-related activities, including adoption and dissemination of good practices;
- h. Development and maintenance of Institutional database through MIS for the purpose of maintaining /enhancing the institutional quality;
- i. Development of Quality Culture in HEi;
- j. Preparation of the Annual Quality Assurance Report (AQAR) of the HEI based on the quality parameters/assessment criteria developed by the relevant quality assurance body (like NAAC, NBA, AB) in the prescribed format;
- k. Bi-annual development of Quality Radars (QRs) and Ranking of Integral Units of HEIs based on the AQAR;
- I. Interaction with SQACs in the pre and post accreditation quality assessment, sustenance and enhancement endeavours.

The university itself offered 10% discount as a grant to all the affiliated colleges so that more no of colleges may join it and would be able to provide the better research facilities to its students and faculty. The subscription cost of these journals through DELNET was Rs 52,500 + 7,500 (Delnet Subscription charges) i.e total subscription cost was Rs 60,000 for per Engg package. Whereas by joining the PTU consortium the colleges have got this package in just Rs 39,375. i.e in actual at 35 % discount in total. It is worthy to mention here that none of the colleges throughout the India has able to get that much discount on any of these e journals. Appreciating the sincere and candid dealings of the university authorities the publisher has offered PTU the reimbursement of the 15 % discount amount to those PTU colleges who somehow missed to join the PTU consortium but has subscribed these e journals through DELNET. Measure to improve Answer Book Evaluation System

1. Inviting three or more Question Papers for each subject:

The idea is to ensure complete secrecy of question paper by having three or more Question Papers from different subject experts. Then the university subject expert should mingle these three Question papers in such a way that it become as model question paper imbibing certain pre-set guidelines for preparing such question papers in a unique manner.

It would be appropriate that the solution to the model question paper is also uploaded on PTU site immediately after the completion of the examination for that particular subject. It will ensure the student self evaluation through these solution to the question papers. Such a solution will also undergo scrutiny of several subject experts. This model solution (modified, if necessary based on external inputs) paper, should also be used for evaluating these papers.

3 Establishment of Nodal Evaluation Centers

It would be desirable that papers of particular subject are evaluated in Subject Excellence centers. Subject excellence centre is the concept involving subject/branch expert stationed at that particular centre and all subject teacher in the particular subject are called in that centre with a view that majority of answer sheet belonging to the subject/branch are evaluated at this centre like all the chemistry teacher for a particular centre are called particular centre only.

Further it is proposed, to establish subject evaluation excellence centre preferably at the centre of excellence for R&D centers. These experts not only help in for preparing of question papers but can also suitably assist the Subject Evaluation at these centers with the help of subject teachers under the control of the Subject Evaluation Centre. The model solution (modified if necessary based on external inputs) should be used at these centers for evaluating answer sheet.

3.	GNIMT, Ludhiana	1. Building Rent & Contingensies for conduct of Exams.
		<u>Eackground:</u> Since December 2010, the Building Rent and contingency expenditure on re-appear students is not paid. On enquiry, an Officer of the Exam. Branch has stated that as the reappear cases are old students of the Colleges as such, the Colleges are responsible to conduct their tests and the University will not pay the Building Rent and Contingency expenditure.
		Suggestions: It is suggested that Building Rent and Contingency expenditure may please be paid as per the norms followed upto December 2010 Exam. and the arrears be paid to the Institutes. The expenditure on lights, fans and generators is the same for regular and reappear cases. As such, the building rent and contingency charges for reappear cases should also be restored and arrears be paid.
		2. Notifications of Merit Lists and Semester End Final Exams.
		Background: Of late, the practice of issuing Merit Lists for each semester and consolidated list at the end of the course has been stopped. In most of the Colleges like ours, Scholarships are paid to the meritorious students on the basis of their positions in the merit lists and in the absence of merit lists, the students have been deprived of such benefits. Moreover, the motivation part of merit list cannot be over-emphasized as the students who figure in the merit list get motivated and others are also motivated to work hard to come into the merit list next time.
		Suggestions: It is suggested that the merit lists for each Semester and also at the end of the course be issued regularly.
		3. Gold Siler, Bronze Medals and Merit Certificates
		Background: Upto last year, the three medals were awarded for first, second and third positions in every course and the merit certificates were also issued to all the students who got first 10 positions in the merit list. Since 2011 only, Gold Medallists have been called for University Convocation and no list for Silver of Bronze Medals and rest of the merit list is issued.
		<u>Suggestions:</u> It is suggested that the Gold Silver and Bronze Medals may be reinstituted. If University wants to award only the Gold Medals during Convocation, the Silver, Bronze and Meri Certificates may be awarded to the students in the respective Colleges' Convocations. Getting medals and merit certificates is a source of motivation and is a matter of pride for whole of their life and they may not be deprived of this privilege.
		4. Issue of Identity Cards to the Academic Council Members
		Background : The Academic Council Members have to visit various Departments of PTU along with attending the Academic Council meetings or otherwise. At present they have to fill in the visitor's slip at every Department and then they have to wait along with the students and their parents in the waiting area. Of course when the chit is placed before the officer concerned, they quickly invite the Academic Council Members and other Directors to the office, but the Academic Council Members/Directors have to wast time and sometimes it causes embarrassment.

	• •	Suggestions: It is suggested that the Institute Login may be provided the Exam. forms, so that the Institute can down-load the Forms in one go and get the same completed from the students well in time, so that the same can be locked finally before the last date.

		Background: As per new University Academic Calendar, the start of Odd Semester is on different dates for 3 rd , 5 th & 7 th and 1 st Semester. It is also mentioned that the three MSTs each for old and new students should be held separately, which means six MSTs in a period of about 3 months or 3 and half months. It is physically not possible to hold Examinations separately for 3 rd , 5 th & 7 th and 1 st Semester.
		Suggestions : It is suggested that the Semester for all courses should start at the same time and the MST dates for all the students may also be the same. It is also suggested that only two MSTs may be planned in a semester instead of three, so that sufficient time is saved for conducting the classes.
