Chief Architect Punjab has submitted that plans prepared by them are based upon the requirements furnished to them by IIT Ropar. However, they are having following observations on the building requirements:

- 1. Requirement of hostels (700 for Boys and 300 for Girls) is on the higher side.
- 2. Faculty residences proposed are on the higher side.
- No requirement of recreation facilities have been submitted. However, CAP
  has included 200m track, Basketball ground, volley ball court etc. in the master
  plan. Clarification on requirement of Indoor stadium, swimming pool or open
  fields has been sought by CAP.

Plans submitted by CAP are placed at Annexure-B.

# Item No. 57.4: To consider the Preliminary estimates submitted by PWD, Mohali for construction of various buildings at Sri Guru Gobind Singh Skill Institute at Chamkaur Sahib, Ropar.

In 69th meeting of IKG PTU's BOG (under agenda item no. 69.3), it was approved that building and boundary wall required at Chamkaur Sahib campus will be created by IKGPTU. Accordingly, PWD Mohali has submitted preliminary estimates for construction of various buildings at this campus amounting to Rs. 115.64 crores, as per the following details:

Against item No. 12 above, administrative approval for an amount of Rs. 147.10 lacs has already been conveyed to PWD. Thus, estimated cost under consideration will be Rs. 11421.17 lacs (Rs. 114.21 Crores).

PWD has informed that the above estimates are only for the buildings with normal specifications. The estimates are not inclusive of Interior decoration work, Special hardware Items, insulation, Special type of Railing, Furniture, Laboratory equipment etc. The estimates are also inclusive of external development works such as Gate, Parking, Roads, Footpath, Storm Water, UGSR/OSP, STP, Pump Room, Treatment Plant, Substation etc.

The estimate submitted by PWD is placed at Annexure-C.
