Senior Architect Punjab was requested to provide the same at the earliest.

After detailed deliberations and discussions, committee decided the following:

- i. Architect Department, Punjab will provide layout plan of the campus alongwith concept plans and broader specifications of the proposed buildings of Phase-I by 04.05.2020 and the same will be put up in the next meeting ofStanding Building Construction Committee of the University for approval. After approval of these plans, detailed estimates shall be prepared by PWD.
- ii. Efforts shall be made to design the layout of the campus and buildings to have minimum earth filling in the campus.
- iii. All Public Health works (except specialized works) shall be done by PWD to avoid delays in execution of works, as already decided by IKGPTU for its main campus works.



#### Action taken:

- The layout plans provided by Department of Architect, Punjab were provided and the same were discussed and approved in 57<sup>th</sup> meeting of Standing Building Construction Committee. The estimates prepared by PWD on the basis of these plans have also been approved in 57<sup>th</sup> meeting of Standing Building Construction Committee.
- The layout/levels of the campus have been designed to have minimum earth filling.
- iii. PWD have finalized the estimates as per the above decision and tenders have been invited accordingly.
- ix) Item No. 57.1: To confirm the minutes of 56<sup>th</sup> meeting of Standing Building Construction Committee held on 29.04.2020.

### **Committee Decision:**

- i. During discussions, it was confirmed by Executive Engineer, PWD, Mohali that all estimates have been prepared by PWD are on the basis of Punjab PWD CSR. After deliberations, committee approved in principal the estimated cost of the proposed works amounting to Rs. 114.21 Crores.

After detailed discussions and deliberations and reasons explained by PWD and Architect for increase in the cost, Committee approved the revised cost as per the following details:

Further, PWD informed that additional estimates for provision of dry cladding in place of wet cladding were approved by SBCC in 55<sup>th</sup> meeting under agenda item No. 55.5 and the same are yet to be approved by BOG. Committee was requested to take a decision on provision of dry cladding or wet cladding in respect of ongoing works. After detailed deliberations and discussions, committee decided to execute the works with wet cladding as per earlier approval of SBCC/BOG. However, after approval of minutes of SBCC by BOG for provision of dry cladding, works of balance buildings will be executed with dry cladding.

After discussions and deliberations, Committee approved the concept plans with total plinth area as 33,984 Sqm. and preliminary estimate amounting to Rs. 127.18 Crores for the proposed buildings at University's Mohali campus-I.

After discussions and deliberations, Committee approved the concept plans and preliminary estimate amounting to Rs. 139.83 lacs for the proposed incubation centre to be developed at 7th floor of main Administrative building, IKGPTU main campus, Kapurthala.

Following additional item was discussed with the permission of the Chair:

Item No. 58.9: To consider and approve the concept scheme and estimate for the external development works of Phase-V at IKGPTU main campus, Kapurthala.

A detailed scheme for the external development works including civil, electrical and PH works was presented by the Architect for Phase-V works (From Guest House to Gate No.3 – including circular road and main road in proposed housing area). After detailed discussions and deliberation, Committee approved the scheme and preliminary estimate for these works as per the following details:-

Civil works - Road work, Boundary walls and : Rs. 484.00 lacs landscape features

Electrical works – External Lighting, LT cables & : Rs. 104.00 lacs pipes, Feeder pillars, DG set and Earthing

 Public Health works – Sewerage, Drainage, RW : Rs. 199.50 lacs harvesting pits, Garden irrigation, Water supply and Fire Fighting systems

Total : Rs. 787.50 lacs
