Admission for MBA, M.A. (Journalism & Mass Communication) and M.Sc. (Chemistry, Physics, and Mathematics) shall be done through Entrance Exam.



- E. All the proposed courses are subject to minimum enrolment of five students in Post Graduate courses and ten students in Undergraduate courses. Admission in these courses will purely provisional, if the admission is less than minimum admission limit till 31st July than that course will be closed, concerned HOD will facilitate the process of closure and transfer of admitted students
