## NOTIFICATION

**Sub: Regarding BBA to BBA Credit Transfer under Pathway Programme of Yorkville University, Canada.**

IKGPTU has signed an Articulation Agreement on May 19, 2022 with Yorkville University (YU), Canada. Under this agreement, students pursuing Bachelor of Business Administration (BBA) course under IKGPTU system can join Bachelor of Business Administration (BBA) course at Yorkville University, Canada under pathway program. Students can opt any of the two Campuses of Yorkville University i.e. Campus in Toronto and Vancouver as per the agreement enclosed herewith.


**Credit Transfer:** The complete BBA programme of Yorkville University is of 120 credits. As per the agreement, Yorkville University has agreed to give maximum 60 credits to students of IKGPTU. On completion of 60 credits in IKGPTU as per section 5/6 of the agreement, students moving to Yorkville University shall have to earn the remaining 60 credits at Yorkville University and after fulfilling all the requirements mentioned in the agreement students will be awarded the BBA degree by Yorkville University.

Under this agreement, both current and alumni students of IKGPTU can take admission in the BBA program at Yorkville University. Students from the IKGPTU's BBA program who achieve the required academic standing will be able to easily transition into the BBA program at Yorkville University and will receive credit toward their BBA for work completed at IKGPTU.

The students who are interested in pursuing the BBA course at Yorkville University, Canada can submit their application along with the copy of the required documents in the office of Dean (Planning & External Programme), I. K. Gujral Punjab Technical University through their respective college/Institute for getting the Letter of Recommendation (LOR).
