2. 2nd installment of 10% of long pending dues (after reconciliation) should be deposited on or before **31.10.2022.**

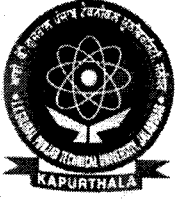
You are hereby requested to comply the above directions before the due date, so that examination centers may be established in your institute, accordingly.

Subject: Regarding deposition of long pending dues by affiliated colleges of IKGPTU.

Sir/Madam,

This is in reference to earlier letter issued vide reference No. IKGPTU/CD/2142 dated 30.09.2022, the next schedule to deposit the long pending dues is as under:-

1. The society/ trust/group/college/institution which did not deposited first installment of 10% of long pending dues on or before 30th September, 2022 are hereby put under "No Admission Zone" for session 2022-23. These institutions should not make admissions w.e.f session 2022-23.
2. All the society/trust/group/college/institution should contact immediately for re- conciliation of pending dues with the following departments on or before 15th October, 2022:-
 - i) The re-conciliation of pending dues related to examination fees of students admitted under PMS (SC/ST students) with Controller of Examination.
 - ii) The re-conciliation of all pending dues related to Admission cell, College Development, Examination etc. with the Department of Finance and Accounts of the University.
3. The last date to deposit the 2nd installment of pending dues is **31.10.2022**. The institutions which have long pending dues (already communicated) should deposit next installment of 10% of pending dues (after reconciliation) on or before **31.10.2022**. The institutions which fails to comply the above schedule, the examination center of such institutions shall be shifted to nearby colleges for December 2022 examinations.
4. The institutions which have not reported so far to deposit the long pending dues the bank guarantees lying with university shall be forfeited and legal proceedings shall be initiated against such colleges.
5. The university shall write a letter to concerned regulatory body i.e. AICTE/PCI/COA etc. to forfeit the bank guarantees lying with them.
