 - e. Creation of teams for verification of eligibility and data of admitted students.
 - f. View and download various reports related to admissions.
 - g. To Correspondence with Colleges / Students (one to one or collectively), as and when required.
2. **Institute Module** : The following provisions shall be made in this module:-
 - a. Provision to update the Institute profile.
 - b. Provision to create sub users / Department wise users to perform tasks individually.
 - c. To create & assign User ID & Passwords to admitting students for uploading of data and documents.
 - d. Verification of documents and Admission Processing Fee submitted by the admitted students.
 - e. Updation of Enrolment Data of admitted students before final approval.
