
Sub.:Criteria for the Allotment of Hostel Rooms in University Hostels on the University Campus.

1. The allotment of the hostel rooms in the University hostels may be carried out on the basis of the sanctioned intake in different courses with 50% of seats allotted to new students in the first round for 2023-24.
2. After the first round, Hostel seats which remains unallocated in a particular Department (s) due to a lack of demand or any other reasons, the Dean (Student Welfare) may allocate such hostel rooms to students from the other Departments as per requirement.
3. The allotment of hostel rooms to the students on the University campus shall be carried out as per the following criteria:
 - a) The hostel rooms shall be allotted by the Warden according to the accommodation plan prepared by the Dean (Student Welfare)/Warden(s).
 - b) 50% of total the hostel accommodation capacity in the campus shall be allotted to the first-year students, remaining 50% of seats shall be allotted to old students as per the approved criteria. After the allocation of all hostel rooms to students as per prescribed criteria in the University hostels, students shall be given the option of hostel accommodation in the University empanelled hostels in near vicinity of the University.
 - c) The hostel rooms shall be allocated on the basis of merit in the qualifying exam.
 - d) The students who are residing within 40 km of the University campus shall not be eligible for availing of the hostel facility on the University campus.
 - e) The bona fide student of the University shall be permitted to avail of the hostel facility.
 - f) The hostel accommodation in the University hostels shall be provided only on a sharing basis.
 - g) The Divyang students or students with disabilities students shall be given first preference in the allotment of hostel rooms in both (Boys & Girls) hostels.

- h) The students defaulting on payment, indiscipline, or any other ground decided by the Dean (Student Welfare), shall not be considered for allotment of hostel rooms.
- i) In case a student has failed in all subjects in the end semester examination or has not appeared in the end semester examination, he/she shall not be eligible for hostel accommodation in the next academic year.
- j) The students studying as day scholars in the University shall not be eligible for admission to the hostels.
- k) The hostel accommodation shall be provided for full-time Ph.D. Research Scholars for a period of 2 years from the date of their registration initially extendable up to 3 years on the approval of a grant of extension in their Ph.D. program by the competent body/authority subject to the availability of the hostels.
