Sub.: Regarding deposition of Long Pending Dues.

In continuation of Office order No. IKGPTU/REG/N/184 dated 04.07.2023 regarding deposition of long pending dues towards affiliated colleges. The matter was represented during the 2nd Meeting of JAC/PUTIA/PUCCA on dated 06.07.2023 by the Chairman of affiliated colleges.

As approved by the Hon'ble Vice Chancellor, the long pending dues shall be deposited as per following schedule:

- 1. All the college shall deposit 100% affiliation/continuation/admission processing and examination related fees etc. for current session.
- 2. The institutions shall submit the details for the total pending amount of PMS scholarship towards government to the Finance and Accounts Department of IKGPTU alongwith relevant proof i.e. sanctioned orders issued by the Government and duly verified by the Student Welfare Department of IKGPTU by 15.07.2023. In case colleges fails to submit the details by this date, shall be considered as no PMS amount is pending.
- 3. The Finance department shall calculate the long pending dues towards affiliated colleges, (head wise/session wise) and shall communicate to all the concerned colleges by 18.07.2023.
- 4. The Finance department shall calculate the difference of serial No. (iii ii) above
- 5. All the institutions shall have to deposit the amount calculated at Sr. No. (iv) above upto 20.07.2023
- 6. The institutions which have pending dues towards the university, shall have to deposit at least 50% of scholarships amount received from the government within seven days from the date of scholarship receipt, against the pending dues of the university. In this regards affidavit should be submitted by the management of the concerned colleges to the University.
- 7. All the existing institutions shall have to deposit the endowment fund of Rs. 10 Lacs in the shape of Joint FDR alongwith affiliation/continuation fee of session 2024-25. However, the new colleges starting in session 2023-24 shall have to deposit endowment fund before the issuance of affiliation orders.
