The condition of NBA accreditation is not applicable for UGC (Non-AICTE) courses as UGC(Non-AICTE) programmes are not covered by NBA. A committee was constituted to give recommendation regarding grant of supernumerary seats to Non-AICTE (UGC) courses. The recommendation of the committee has been approved by the Vice Chancellor cum Chairman, Academic Council to grant the approval for session 2021-22 and from session 2022-23 onward. The University’s policy for UGC (Non-AICTE) may be amended as under:

For AICTE courses: AICTE guidelines shall be applicable alongwith the condition of NBA Accreditation and any other guidelines issued by AICTE from time to time.

For UGC (Non-AICTE) courses: AICTE relevant guidelines shall be applicable except NBA Accreditation.

- a) The minimum admissions shall be 10 to start a course.
- b) Each Course shall be of 4 Credits with minimum 120 Contact Hours.
- c) Candidates may take the examination of IKGPTU in proposed courses. without joining the course by paying the requisite examination fees as decided by the university time to time.
- d) Syllabus for the Certificate Course in French, German recommended by BoS. The syllabus of Japanese, Spanish and Chinese will be discussed at later stage.
- e) The examination scheme in the said courses shall be as follows: Total Marks: 100 (internal 40, External 60) The course shall be of 100 marks in each semester. The total marks will be 200 for the entire course. Internal Assessment-40 (24 marks for best of two MSTs. 10 marks for Assignment/viva-voce and 6 marks for Attendance). To assess the speaking/listening/reading skills of the students, the viva voce/oral exam shall be the part of internal assessment of 40 marks. The final examination of 60 marks shall be conducted by the examination branch of the university or as decided by the University time to time.
- f) The BoS recommended the text books for French and German.
- g) Currently, the course fee is 7,080/- Rupees (including tuition fee, examination fee and GST) for the entire course. It was recommended that the decision pertaining to the revision of fee may be taken in a separate meeting constituted by the competent authority.
