## **Terms and Conditions / General Instructions**

1. The minimum qualification is as per UGC/AICTE norms with Ph.D in relevant field. In case, candidates with Ph.D qualification or NET/SET/SLET are not available, then candidates with minimum qualification shall be considered.
2. Hiring of Guest Faculty is purely on temporary basis for the session January to June 2024. The guest faculty shall be engaged/hired as per work load and requirement in accordance with the academic calendar issued by the IKGPTU.
3. Selected candidate(s) with Ph.D Qualification shall be paid an Honorarium @ Rs. 1000/- (One Thousand) as per one credit hour and Candidates with Master's Qualifications, shall be paid Honorarium @ Rs. 750/- (Seven Hundred and Fifty only) as per one credit hour with a monthly ceiling limit of Rs. 50,000/- (Fifty thousand only).
4. The empanelment as Guest Faculty (purely on hourly basis) will be for a period of for current session and further extendable as per teaching load and requirement of IKGPTU and also subject to selected candidate's performance and recommendations by concerned Head of Department.
5. The timing for presence of hired guest faculty on the all campuses shall be 9 AM to 5 PM irrespective of the teaching load allotted in a day.
6. The appointment as Guest Faculty can be terminated by the IKGPTU, without assigning any reason.
7. In case if hired guest faculty wish to leave the assignment, he /she will have to give one-month notice to the University. If he/she fails to give one-month notice to the University, he/she will not be entitled for one month salary.
8. The performance as Guest Faculty will be monitored after every month and if found unsatisfactory, the appointment as Guest Faculty can be terminated, without assigning any reason.
9. Selected candidates shall take full teaching load as prescribed in the curriculum and administrative load as assigned by IKGPTU.
10. Selected candidates shall not be entitled to provident fund, pension, gratuity, medical attendance / treatment / Dearness Allowance or any other benefits available to the University's regular faculty.
11. Selected candidates will not entitle for any right or claim for regular appointment in the University.
12. In addition, selected candidates may be assigned the work of evaluation of Class Assignment/Home Assignment/ Sessional / Drawing/Laboratory Works/Class Tests/End Semester Examination/ Evaluation Work/ Industrial Visits/ Student-Faculty Advisor/ coordinator Training & Placement/ Inter-college Tournaments and Cultural Activities etc. or any other associated works by the Head of the Department or the Competent Authority.

Selected candidates shall submit an undertaking on Affidavit of Rs. 100/- stamp paper stating that you understand and accept all the terms and conditions of the appointment offer as Guest Faculty that this assignment as Guest Faculty is purely temporary in nature and that you will have no right to claim for the absorption into a regular appointment to the post in IKGPTU.
14. Guest Faculty who are hired/ engaged shall be required to take lectures in main and constituent campuses of IKGPTU as per requirement.

15. No TA/DA shall be paid for attending the Interview.
16. Offer letter to the empanelled candidate will be issued as per the requirement of concerned stream/disciplines.
17. Interested candidates are required to report at IKGPTU Amritsar Campus, Inside Govt. Polytechnic College, Near CIPET College, PO, Chheharta, Amritsar, Punjab 143105 for the verification of Original Academic and experience certificates. After the verification of original documents, interview shall be conducted.

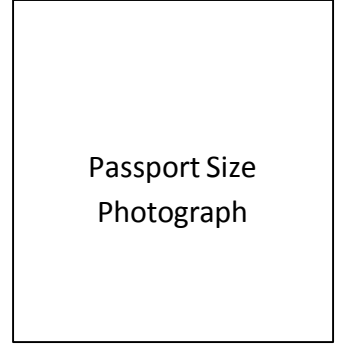
