Note:

- 1. *In case of late submission of online application affiliation/continuation fees shall be deposited with in two working days after locking the online application.
- 2. In case of restoration of seats applied by institute, institutes have to upload the previous affiliation order for break in continuation of seats with Restoration Processing fees.
- 3. In case of any new addition /deletion / editing/ correction of nomenclature/seats of AICTE/PCI/COA/UGC courses etc., the concerned institute may send request to University immediately after issuance of notification by the concerned regulatory body. University shall process such cases without any late fee.
