### **Agenda 80.4.1: To consider about the extension in deputation period of Dr. Sonu Bala Garg, Assistant Professor (ECE), IKGPTU Hoshiarpur Campus.**

Dr. Sonu Bala Garg, Assistant Professor (ECE) joined this University on deputation basis at IKGPTU Hoshiarpur Campus from Baba Hira Singh Bhattal Institute of Engineering & Technology, Lehragaga w.e.f 30.01.2015.

With the approval of the competent authority, her deputation period was extended from time to time and currently the deputation period has expired on 29.01.2023.

Dr. Sonu Bala Garg vide her application 02.12.2022 requested the University to extend her deputation period for another one year. In this regard, no NOC has given by the parent Dept. i.e. BHSBIET, Lehragaga in respect of Mrs. Sonu Bala Garg.

As per the rule position mentioned above, the deputation period of the incumbent may not be extended, as she has already completed the 09 year of her deputation at IKGPTU on 29.01.2023.

In this regard, it is also brought to your kind notice that the University has received D.O letter No. 471 dated 16.11.2022, from Director, Department of Technical Education & Industrial Training, Punjab to adjust the staff of BHSBIET, Lehragaga as per prevailing rules. It is worth to mention here that name of Dr. Sonu Bala Garg is included in the list of staff, which has given their consent for shifting in IKGPTU.

The University has received order from Additional Chief Secretary to Govt. of Punjab vide No. TECH-TE-2022/1/2023 -4TE2/1/541153/23 dated 10.04.2023 via email regarding extension in deputation period of Mrs. Sonu Bala Garg, Assistant Professor (ECE) from BHSBIET, Lehragaga to IKGPTU for a period of one year.

Keeping in view of above, the matter is placed before the BOG for consideration.

**Agenda 80.4.2: To consider about the extension in deputation period of Mrs. Paramjit Kaur, Deputy Registrar.**

Mrs. Paramjit Kaur, is working in this University on the post of Deputy Registrar on deputation basis from MRSPTU, Bathinda w.e.f 23.02.2021. With the approval of competent authority, her deputation period was extended for further period of one year upto 22.02.2023.

As per No Objection Certificate issued by the parent Dept. of Mrs. Paramjit Kaur vide No. 1734 dated 14.08.2020 that "*this University has no objection her for deputation to I.K. Gujral Punjab Technical University Jalandhar, Kapurthala provided concerned University ready to accept her deputation with standard terms and conditions.*"

As per terms of Deputation issued by this University vide No. IKGPTU/REG/HRM/5708 dated 22.02.2021, the period of deputation is one year in the first instance, from the date she joins duty at IKGPTU extendable upto three years based on performance review/till the regular appointment at IKGPTU/as per discretion of MRSPTU, whichever is earlier.

The University has received letter no. TECH-TE-2021/7/2023-TE-1/534950/1-4 dated 27.3.2023 from Department of Technical Education & Indl. Training, Punjab vide which the deputation period of Mrs. Paramjit Kaur has been extended for another period of one year. The matter is placed before the BOG for consideration.
