With the approval of competent authority, the partial amendment to IKGPTU Ph.D. regulations 2022 notified vide Notification No. IKGPTU/REG/NF/R&D/1971 dated 19-09-2023, the clause 10 a(i) and 20 (a) is as under:

However, if a Professor/Associate Professor with Ph.D. degree have only three (03) research publications in SCI/SCIE/ESCI/ SSCI/AHCI/ABDC (A*,A and B only) and two (02) publications in UGC care/Scopus journals, shall also be considered as Ph.D. supervisor with limited intake of Ph.D. students equivalent to Assistant Professor with the approval of competent authority.
	Any regular Assistant Professor of the University/Institution deemed to be a University/College with a Ph.D. degree at least three research publications in SCI/SCIE/ESCI/ABDC (A*,A and B only) journals shall be considered for all subjects except Humanities and Languages shall be recognized as Research Supervisor in the university where the faculty member is employed or in its affiliated post graduate colleges/institute. In case of Humanities and Languages discipline, the publication in peer review refereed journals shall be considered.	Any regular Assistant Professor with a Ph.D. degree at least three research publications in SCI/SCIE/ESCI/SSCI/ AHCI/ABDC (A*,A and B only) journals shall be considered to be recognized as Research Supervisor in the university where the faculty member is employed or in its affiliated post graduate colleges/institute.
