
Dear Sir/ Madam,

I am pleased to inform you that the Council of Architecture has decided to conduct Post Graduate Entrance Test in Architecture (PGETA) at national level on July 28, 2024, and August 04, 2024, for admission to the Post Graduate programmes being imparted at the architectural institutions approved by the Council for the academic session 2024-2025. The brochure and registration details of PGETA has been made available at the Council's PGETA website [www.pgeta.in](http://www.pgeta.in). A copy of the PGETA 2024 Brochure is also attached herewith for your ready reference.

The Test shall be a Computer Based Test and will be conducted at the selected Test Centres at the institutions in the country which are already conducting NATA 2024 during 2024. The First Test will be held on **July 28, 2024 from 10:00 AM to 01:00 PM** and Second Test will be held on **August 4, 2024 from 10:00AM to 01:00 PM**. The duration of PGETA will be three hours and there will be 75 MCQ type questions carrying 100 marks.

All the institutions approved by the Council for imparting B.Arch. and/or M.Arch. degree programme in the country are therefore requested to bring this to the notice of the students currently pursuing Final year B.Arch. course enabling them to register for PGETA 2024 for admission into Post Graduate programme in Architecture.

The institutions are further requested to ensure that candidates are admitted into 1<sup>st</sup> year of PG programme being imparted by them for the academic session 2024-2025, based on the PGETA conducted by the COA.




