- Rates to be quoted by the bidder should be filled in Bill of Quantities.

- 5. AMC is for one year and may be extended for further period of one year or more on same rates, terms & conditions on mutual consent/mutually agreed between IKGPTU and the Firm.

- 7. The contractor shall have to maintain a Log Book for the cleaning of Water Storage Tanks and shall have to be get it verified from the Estate Office.

The bidder is advised to visit and examine the site where the work is to be executed and its surroundings or other areas as deemed fit by the bidder and obtain for itself on its own responsibility all information that may be necessary for preparing the bid and execution of the work.
