Sub.: Regarding the submission of semester fee/late fee for the students of IKGPTU Kapurthala Campus & Constituent Campuses of IKGPTU.

The following decisions have been made regarding the submission of semester fees/late fee fine for the students of IKGPTU Kapurthala Campus & other Constituent Campuses of IKGPTU from the upcoming session:

- 1. No fine will be charged from the students within 30 days from the start of semester as per academic calendar of the University.
- 2. After last date, fine of Rs. 500/- will be charged for first 15 days and fine of Rs. 1000/- will be charged for next 15 days.
