Sir/Madam,

This has a reference to the subject cited above.

Further, it has come to the notice of the PCI that various State Governments have started the admission process and Counselling is already at 3<sup>rd</sup> Stage.

In this connection, your kind attention is invited to order dt.9.5.2025 passed by the Hon'ble Supreme Court in MA No. 711 of 2025 in CA No. 9048 of 2012 wherein the court interalia held as under -

2. The application is allowed, in terms of prayer clause "a" which is extracted below:  
"(a) Grant extension of completion of approval process of the institutions up to August 31st 2025 and appeals/compliances process till September 30th 2025 to the Applicant Pharmacy Council of India for the academic year 2025-2026, and further extend the completion of counselling till October 30th 2025."

In view of above, all State Governments are requested to align their admission process strictly in accordance with the timeline fixed by the Hon'ble Supreme Court for 2025-2026 academic session.
