**Sub: Provisional registration and course work schedule for admission to
Ph.D. Program 2025-26 (summer).**

The candidates previously declared eligible on the basis of Ph.D. entrance test and interview as per IKGPTU Ph.D. regulations of 2022 and selected for Ph.D. admission 2024-25 (who have not yet admitted and not enrolled for Ph.D. course work but are eligible for the same) and candidates selected for PhD admission for IKGPTU as well as autonomous colleges session 2025-26 summer are required to do provisional registration at the online link <https://phd.ptu.ac.in> as per following schedule as approved by the competent authority:

1. Activation of Online Provisional Registration Form (In the login id of selected candidates): **12-09-2025 11:00 AM.**
2. Last Date to fill the online provisional registration form is **18-09-2025 03:00 PM**
3. Last Date to deposit the fee: **18-09-2025 (Provisional Registration Fee = Rs. 20,000/-).** Fee will be deposited through online mode only (Credit Card/debit Card/Net banking etc.) after the submission of provisional registration form.
4. The Ph.D. course work shall be offered at IKGPTU Main Campus Kapurthala and approved research centres. List of approved research centres will be issued separately.
5. University Main Campus and approved research centres will be offering core/elective subjects/seminar in the concerned branches on regular basis. Students are advised to opt for course work subjects as per availability at these centres with the guidance/advice of their supervisors depending upon their tentative research area. Student has to give three choices of research centres in order of preference in their provisional registration form. University shall allot the centre as per choice of student subject to administrative feasibility.
6. After successful online submission of the provisional registration form, student shall be required to submit its hard copy (printout) with the consent of Ph.D. supervisor. Students in service are required to get their provisional registration form forwarded from their current employer.
7. Submission of the signed provisional form by candidate in the university by **24-09-2025.**
8. Date of allotment of Provisional registration number and course work subjects by - **25-09-2025.**




9. Reporting of students at university or research centres on or after **29-09-2025** (onwards) with following documents:
 - Print out of provisional registration form.
 - Any one photo-ID proof in original (e.g. Aadhar card, driving license, voter-ID, passport etc.)
 - NOC from current employer
10. Start of Classes: **29-09-2025**.
11. Last date to deposit Semester fee: **25-09-2025 (July 2025 to Dec 2025) of Rs. 25,000/-**.
12. Submission of migration certificate by the student to IKGPTU latest by: **15-10-2025**.
13. The revised syllabus if any will be uploaded on University website on or before **29-09-2025**.
14. If the candidate fails to deposit fee by the last date i.e. 18-09-2025, his provisional registration process shall be automatically cancelled for the session 2025-26 (summer). Such candidates will be considered for provisional registration in next semester only as per their validity of admission. Please note that a student once admitted to Ph.D. program can attend course work in current semester or next consecutive semester and not beyond that.
