PREAMBLE

3. Opportunities

4. Reporting

I.K. Gujral Punjab Technical University Jalandhar will be able to access reports either on platform or via monthly/quarterly reports as the case may be. These reports will primarily provide a broad level view of usage by registered students.

Role and Responsibilities of I. K. Gujral Punjab Technical University Jalandhar

1. Registration of students

1.1 Registration of students via dedicated college url

I.K. Gujral Punjab Technical University Jalandhar will share a dedicated college url with the students and the students will register via the same

1.2 Registration of students via excel upload (Applicable only if student details are being shared via excel sheet)

I. K. Gujral Punjab Technical University Jalandhar will register the student details on the platform via upload format given in Annexure A with the consent of students. All students registered by the I. K. Gujral Punjab Technical University Jalandhar will have free of cost access to the services mentioned in this MoU ..

It shall be the sole responsibility of the I. K. Gujral Punjab Technical University Jalandhar to ensure that only the personal information of students who have expressly consented to the sharing of their data with Naukri Campus is provided. Such consent must be valid, informed, and in compliance with the provisions of the Digital Personal Data Protection Act, 2023 (DPDPA). The I. K. Gujral Punjab Technical University Jalandhar shall remain fully responsible for ensuring lawful data sharing and shall indemnify and hold Naukri Campus harmless against any claims, losses, or liabilities arising from any breach of data protection obligations attributable to its actions or omissions.

2. Promotion of Naukri campus offerings to students

I.K. Gujral Punjab Technical University Jalandhar will actively promote Naukri Campus offerings to all students ensuring they are informed of these opportunities multiple times throughout the academic year. Students registered on the platform will receive transactional/promotional communications via multiple communication channels such as email, WhatsApp, SMS etc.



3. Letter of Recommendation (For universities only)

The I.K. Gujral Punjab Technical University Jalandhar will issue a letter of recommendation to all affiliated colleges, encouraging them to promote the free services provided by Naukri campus as per scope of this MoU.

REPRESENTATIONS AND WARRANTIES

Each Party represents and warrants to the other Party that:

- a) it is a business duly incorporated, validly existing and in good standing under the laws of its jurisdiction of incorporation;
- b) it has all necessary rights, power and authority to enter into this MoU and perform its obligations hereunder;
- c) it will comply with all Applicable Laws while performing its obligations and duties under this MoU;
- d) it has no outstanding MoU or obligation that is in conflict with any of the provisions of this MoU or the performance thereof, or that would preclude it from complying with the provisions hereof, or that would create a conflict of interest with the provisions hereof and further represents and warrants that it will not enter into any such conflicting MoU or obligation during the term of this MoU. Each Party will inform the other Party, immediately upon becoming aware, of any matter which might give rise to a conflict of interest with its duties under the terms of this MoU;

CONFIDENTIALITY

The Parties agree that all Confidential Information is proprietary to the Disclosing Party and will be kept strictly confidential. The Receiving Party will use Confidential Information only for the purposes of this MoU and will not disclose it to any third party, except as required by law, after giving reasonable notice to the Disclosing Party. Confidential Information may be shared with employees, officers, or advisors who need to know it for performing the Services, provided they are bound by equivalent confidentiality obligations. Upon request or termination of this MoU, the Receiving Party will destroy all copies of the Confidential Information. The Receiving Party acknowledges that unauthorized disclosure may cause irreparable harm to the Disclosing Party, entitling the Disclosing Party to seek immediate injunctive relief.

INTELLECTUAL PROPERTY

Each Party will retain their respective intellectual property rights, title and interest in their modus operandi, patents, copyrights, trademarks, proprietary marks and/or licensed software, service marks, trade secrets and any other form of intellectual property ("Intellectual Property Rights") that are disclosed or generated during the term of this MoU.

The Parties further agree that neither Party will acquire any right whatsoever, through use in commerce or otherwise, in the Intellectual Property Rights of the other Party on account



of the limited permitted use as per the terms of this MoU. All such rights pertaining to the use and title of all Intellectual Property Rights of the Parties will exclusively vest with the respective Parties.

No Party may, under any circumstances, seek to register any trademark, business name, business processes, inventions, company name, or domain name using or incorporating the Intellectual Property of the other Party and each Party acknowledges that upon expiry or termination of this MoU, it will have no right whatsoever in connection with the Intellectual Property Rights of the other Party.

Indemnification

The Parties hereby agree to indemnify, reimburse, defend and hold harmless the other Party, its affiliates and other officers, directors, employees, agents, successors and assigns, from and against any and all costs, losses, damages, lawsuits, deficiencies, claims and expenses (including court costs and reasonable attorney's fees) incurred or suffered by the other Party in connection with or arising out of or resulting from or incidental to:

- (a) any breach or obligations, representations and warranties as set out in this MoU; or
- (b) willful default or gross negligence on the part of the other Party during the course of the performance of this MoU.

Dispute Resolution

This MoU shall be governed by and construed and enforced in accordance with the laws and regulations of the Republic of India, excluding its conflict of laws rules to the extent such rules would apply the law of another jurisdiction. All disputes, differences of opinion and controversies arising between the Parties out of this MoU shall be resolved amicably, failing which they shall be finally settled by a sole arbitrator mutually appointed by the Parties herein. The Arbitration shall be conducted in accordance with the Arbitration and Conciliation Act, 1996 or any amendment thereof for the time being in force.

Governing Law

This MoU shall be governed by and construed in accordance with the laws of the Republic of India. The courts in Delhi shall have exclusive jurisdiction over any disputes arising from this MoU.

Amendments

Any amendments or modifications to this MoU must be made in writing and signed by both parties.

Termination





2. **No Partnership:** Nothing in this MoU shall be construed to create a partnership, joint venture, or agency relationship between the parties.
3. **Assignment:** Neither party shall assign or transfer any of its rights or obligations under this MoU without the prior written consent of the other party.
4. This MoU supersedes all prior written or oral MoUs, communications, and understandings between the parties with respect to the subject matter hereof.
