2. The contract will be for the tenure of 11 months earlier. Maximum age for the candidates will be sixty years.
3. The condition of Punjabi pass at Matric level will be as per Punjab Government norms.
4. Reservation will be given as per Punjab Government regulation. If candidate(s) of reserved category do not come for "Walk-In-Interview" or "Found not Suitable" by the Selection Committee, then post may be filled with the candidate of other categories.
5. The performance will be monitored after every month and if found unsatisfactory, the appointment can be terminated without assigning any reason.
6. In case if appointed candidate wish to leave the assignment, he /she will have to give one-month notice to the University. If he/she fails to give one-month notice to the University, he/she will not be entitled for one-month salary.
