TERMS, CONDITIONS AND TECHNICAL SPECIFICATIONS

1. Rates to be quoted by the bidder should be filled in Bill of Quantities.
2. Rates to be quoted by the bidder shall be deemed to be inclusive of all types of direct and indirect taxes imposed by Central/State Govt. and local bodies such as excise duty, sales tax, GST, works contract tax, service tax, royalties, duties, cess, octroi and other levies as applicable and also include all import duties. The rates shall also be inclusive of all taxes, duties and other charges imposed outside the country on the production, manufacture, sale and transport of Contractor's equipment, plant, materials and supplies to be used on or furnished under the contract and on the services performed under the contract. No additional amount shall be paid or claim be entertained on this account by IKGPTU.
3. Rates to be quoted shall also be inclusive of all royalties, fees and other payments in respect of patents, patents right and license(s) which may be payable to patentee, licensee or other person or corporation and shall obtain all necessary licenses/permissions. In case of any breach (whether willfully or inadvertently) by the Contractor of this provision, the Contractor shall indemnify IKGPTU, its officer and employees against all claims, proceedings, damages, costs, charges, loss and liability which they or any of them may sustain, incur or be put to by reason or in consequence directly or indirectly of such breach and against payment of any royalties, damages or other money which the IKGPTU may have to make to any persons or pay in total to the patent rights in respect of the users of any machine, instruments, process, articles matte or thing constructed, manufactured, supplied or delivered by the Contractor under this contract.
4. All the works shall be completed within a period of 15 days from the date of issue of letter of acceptance by IKGPTU.
5. Payment Terms:
95% payment shall be made on completion of all the work in all respects. Balance 5% payment shall be made after Three(3) months of completion of work and removal of defects (if any) in the works.
Statutory deductions shall be made from the payments made by IKGPTU to the Contactor as per law of the land. The deductions shall be made as per prescribed rates prevalent from time to time. Amount of tax deduction shall be deposited with the concerned authorities and tax deduction certificate shall be issued by IKGPTU.
6. The bidder is advised to visit and examine the site where the work is to be executed and its surroundings or other areas as deemed fit by the bidder and obtain for itself on its own responsibility all information that may be necessary for preparing the bid and execution of the work. The cost of visiting the site and collecting relevant data shall be at the bidder's own expenses. It is a condition of the tender that the tenderer is deemed to have visited the site and satisfied himself with all the conditions prevailing including any difficulties for executing the work.
7. All the pages of this document shall be submitted by bidder duly signed and stamped by the bidder.
8. All the works shall be executed, measured and paid as per Bill of Quantities.
9. Warranty of repair will be Three(3) months from the date of installation. In case of any defect/breakdown in the repaired motors, the agency/contractor/firm will get it repaired at its own cost within a period of Two(2) days.
